

### Letter from the President

#### Oslo - Bigger than Lillehammer!

As these paragraphs are being written, the Northern European evenings are beginning to brighten, and there are countless other signs that our period of hibernation is drawing to a close. Nevertheless, we are still wearing our coats, and still only the most hardy and dedicated are playing their tennis out of doors. It comes as something of a surprise, then, to realise that this is the last Newsletter to appear before we all migrate to Oslo to experience professional enlightenment and the midnight sun (in that order) at our 4th Conference.

The final announcement of the programme is being distributed across Europe, and the registration forms arrive. With such an intensive programme of plenary and parallel sessions, it would be invidious to mention any individual events or speakers, but the programme committee have matched their colleagues in Montpellier in pulling together speakers and of the highest quality from across Europe and beyond. Montpellier's continuing education sessions were extremely popular, and already there are signs that many of the Oslo sessions will be fully booked in a very short time.

With Lillehammer's triumphant Winter Olympics still fresh in the mind, there is probably no need to emphasize here how good the social side of the Conference will be. A nation that can produce a crowd which sings "Happy birthday" to its ski champion as he tries to win a gold medal has no lessons to learn about enjoying itself. And the Local Organising Committee have put together a terrific programme which respects Norwegian traditions while remaining accessible to the rest of us. It is probably better not to mention the English dele-

gates' plan to play a game of cricket starting at midnight on the Thursday or Friday night.

So, if you have not already done so, get your registration form from under that pile of papers, or the form reproduced in this issue, and send it by fax to the Local Organising Committee in Oslo. Either way, make your reservation, and help make the 4th European Conference of Medical and Health Libraries an event to eclipse the Winter Olympics and the World Cup.

#### Official EAHIL Business - Board and Council Meetings and General Assembly in Oslo

The biennial conferences are always an opportunity to push through official Association business and in Oslo there will be the usual round of Executive Board and Council meetings, followed by the General Assembly. The Council is on Tuesday 28th, and the time has been put back to 16:00 (the conference programme had it at 13:00) to allow Councillors to travel to Oslo that morning and keep their expenses to a minimum. The General Assembly will be at 15:00 on Wednesday 29th, and the main purpose of this paragraph is to urge you to make EAHIL a working, democracy by attending, by speaking on topics that concern you, and by voting.

#### EAHIL Elections

On the subject of voting, please remember that we are now in the midst of our elections, and need to elect a new President, 2 Executive Board Members and new Council members to take office on January 1st, 1995. The ballot papers were sent out end of March to all full Members. We count on your participation. The higher the vote the healthier the result, so please make sure that those of the election committee who count the votes have a long day's work ahead of them.

## Ethics

The first meeting of the new ethics working group will also take place in Oslo. There have been enough volunteers to begin work on a code of professional ethics for European medical librarians, but it would be very helpful to have representatives from Southern and Eastern Europe; If you are interested in joining the group, please write to EAHIL headquarters.

## A vote of thanks

And finally... This column is appearing in the last issue of the Newsletter to be produced under the gentle, impeccable guidance of Jean Shaw's editorship. EAHIL's membership is dispersed throughout Europe and our Newsletter is without question the most important means for maintaining the Association's identity. In the years between our major conferences, it is the big tangible benefit of membership and to a very considerable extent the continuity and reputation of EAHIL rests squarely on the editor's shoulders. Before I was elected President, I realised all these things in a abstract sort of way; in the past couple of years I have come to appreciate fully just how good a job Jean has done. Deadlines have been met, late contributors have been gently and kindly persuaded to produce their paragraphs (as I know well!) and every quarter there is another edition which reflects credit on the Association and on the editor.

At our January meeting, the Board made a formal vote of thanks to Jean for her efforts and it is absolutely appropriate for that to be marked here in the Newsletter itself. Fortunately, it is possible to end this section on an optimistic note - or two optimistic notes - to be precise. Firstly, the new editor is Liisa Salmi, from Kuopio in Finland, and I am sure she will also do an excellent job; and secondly she will be able to call on the expert help of her predecessor, because Jean is staying on as English-language editor.

### **Pre-Conference Seminar in Stockholm, on June 27, 1994**

***Pre-Conference seminar at Karolinska Institute Library and Information Center (KIBIC) of Stockholm, Sweden, on Monday, 27th June 1994, 12-5 p.m.***

KIBIC is Sweden's national resource library in medicine, odontology and the health sciences. The library accounts for 25% of the entire volume of document delivery services in all university and research libraries in Sweden. MIC, the Medical Information Center at KIBIC, is the primary organization for bibliographic databases in biomedicine in Sweden, with access to 17 medical databases on the MIC computer system, and 31 databases through the MIC gateway to the National Library of Medicine in USA.

The seminar will present the goals, scope and operation of a national resource centre in medicine and allied health sciences. Recent developments in information technology applied to document delivery and information retrieval will be described and demonstrated, and the new facilities and media for medical students in a problem-based curriculum will be presented.

Au moment où j'écris ces lignes, les soirées scandinaves ont commencé à briller, et c'est un des signes avant-coureurs, parmi tant d'autres, de l'annonce de la fin de notre période d'hibernation. Cependant, nous portons toujours nos manteaux, et seuls les plus courageux et décidés jouent leur partie de tennis en plein air. Et c'est avec surprise que l'on réalise soudain que c'est la dernière Newsletter qui paraîtra avant notre migration vers Oslo. Notre 4ème Conférence nous permettra de suivre la progression de notre profession et de voir le soleil de minuit (dans cet ordre).

L'annonce finale du Programme a été distribuée à travers l'Europe, et les bulletins d'inscription arrivent rapidement. Avec un programme de sessions plénières et parallèles d'une telle intensité, il serait désobligeant de mentionner tel orateur ou tel évènement; le Comité de Programme a égalé ses collègues de Montpellier dans le but de réunir des conférenciers de grande qualité d'Europe et d'ailleurs. **Déontologie**

La première réunion du nouveau groupe de travail sur l'éthique se tiendra à Oslo. 

### Electronic Journals - some speculation *Les journaux électroniques - quelques spéculations*

*La communication dans la recherche ou en médecine se fait essentiellement par les périodiques. Ce sont les éditeurs qui contrôlent toute la chaîne de la publication et, en fin de parcours, les bibliothèques qui souscrivent à ces périodiques. L'utilisateur est ainsi informé de ce qui le concerne dans sa spécialité; un autre moyen, pour lui, est de rencontrer ses confrères dans des congrès ou de partager une correspondance. La conférence électronique représente aujourd'hui un des moyens de convergence de toutes ces sources d'informations, formelles et informelles. La publication électronique prend plusieurs formes : texte intégral, CD-ROM, fourniture de documents électronique. Cependant, cela nécessite des moyens non négligeables en matériel et en investissements. Le sujet est immense et il est très difficile à l'heure actuelle de savoir quel sera l'avenir de la communication scientifique.*

The communication of research and practice in medicine is presently dominated by journals. The researchers produce papers and they submit them to journals. The publisher of a reputable journal is then responsible for the editing, refereeing, marketing, distribution and selling of the publications under their control. In most cases, the author transfers the copyright to the publisher at some stage within this process, though I suspect that most medical researchers are not aware of this.

Another part of this cycle involves libraries, which are requested by their clients to subscribe to particular journal titles. For ease in dealing with subscriptions, often in a number of currencies, most of the larger libraries use subscription agents, who automatically renew subscriptions, and present the library with a single invoice (and an occasional supplementary adjustment). We as librarians then arrange and control the issues and volumes as they come into the library, so that our clients can find the items they need.

In the meantime publishers, anxious that their publications are referred to in prestigious indexing and abstracting services, make the issues available to publishers of indexing and abstracting services such as ISI (the publishers of the Science Citation Index), the National Library of Medicine and Excerpta Medica. The advent of the electronic forms of these indexes and abstracts (MEDLINE and EMBASE) has taken much of the tedium out of literature searching as well as adding to the completeness of the search. It has also led to the greater involvement of the end-user in literature searching, but scientists do not simply rely on literature searches. The process of gathering information involves a variety of sources outside the printed literature - meetings, conversations and correspondence with colleagues. With electronic mail and electronic conferencing perhaps we are beginning to see a convergence of this type of "informal" information exchange with the printed methods of communication.

It is instructive to look at this conventional cycle from author to audience from another point of view. The authors receive no direct financial advantage (they may even have to pay page charges); the publishers and the subscription agents provide a service from which they must derive a profit or go bankrupt; and the libraries pay for the service or product, add value to it by organizing it in a rational fashion and act as mediators in balancing the various demands of researchers and practitioners within their institution.

We should not forget that the driving force behind all this is the authors' desire to see their research in print. So much depends on having a goodly number of publications to your name: further research grants, promotion, and general recognition in the scientific community, giving rise to more tangible rewards. Although numbers of papers are significant, publication in a reputable, peer reviewed journal, preferably with a high rating in the Journal Citation Reports is undoubtedly the desire of most medical (and other) researchers. The pressure to publish is such that it has driven some researchers to make three papers out of results, which would justify only one; and a few to plagiarize or falsify their data. The point I want to make here is that purely electronic journals will only succeed if they are accepted as a valid substitute for the present system of publication.

There are probably three main types of electronic journal at present:

- Those that have paper counterparts - the New England Journal of Medicine is to be found in both paper and electronic forms;
- The purely electronic, refereed journal - Online Journal of Current Clinical Trials has no paper counterpart;
- A whole host of communications on electronic network, bulletin boards - these are very variable in form, function and quality.

The audience they can reach is limited by the networking capabilities of the country or institution.

Most publishers nowadays use computers in the publication process. At some stage, therefore, most articles are likely to be in an electronic form before being printed onto paper. Full text electronic forms of a number of conventional journals are now available both on CD-ROM and on-line. On the whole these services seem to me to be aimed at the end user. BRS Search is a package of information retrieval tools and full-text journals, there are CD-ROMs which contain a back-run of a particular journal or set of journals. For many medical libraries such services would duplicate what could be done with MEDLINE or EMBASE and a reasonable backrun of the paper journals concerned. But it could depend on price and I can certainly see the advantage of a package, such as the American Psychiatric Association CD-ROM, which contains the full text of some mainstream psychiatric journals, being placed in small, perhaps somewhat isolated, psychiatric hospitals or centres. If we carry this concept several stages further there would be no need for institutional libraries to acquire the paper versions, electronic versions could be networked round the campus and the value added service that we presently provide in making material available on site would be bypassed.

Some publishers notably Springer Verlag and Elsevier have embarked on more ambitious experiments with the electronic forms of their journals. Experimental projects in conjunction with American universities (Red Sage and TULIP) have concentrated on the electronic delivery of documents to the researcher's desk. This is, I am sure, one of the things that the researcher wants. Very few people want to move any distance to get material from a library. For most people the ideal world would be one in which one either did one's own literature search (or got someone else to do it) and then having identified a relevant document, press a single key and, lo and behold, it is there, either typing itself out on the printer or in a file on the hard disk. The experimental use of ADONIS (a number of biomedical journals on CD-ROM produced by Elsevier) in conjunction with the British Library was an experiment in document delivery. At the time few university campuses in the U.K. were fully networked so the experiment was confined to the production of a requested article at the British Library, which was then sent in the ordinary way to the requesting library. But it was a start.

The provision of journal articles electronically, which are as readable and visually attractive as their paper counterparts, takes both investment in technology and the development/adherence to standards. Also the electronic delivery of documents by this method is limited by the extent to which networks have developed and

penetrated institutions down to the level of having a networked computer on each researcher's desk. It is also limited on a global scale. Networks are extensive, but in some places they are definitely less extensive than others. Up until now these electronic forms of established paper journals are potentially a means of obtaining a supplementary income for the publisher. What happens if and when networks are everywhere, electronic journals are accepted as respectable by the research community, and our clients find this a much less time consuming exercise than the present conventional library services provided by holdings or through inter-library loans.

Several scenarios present themselves. The publisher might sell articles directly to our clients - by-passing the library and subscription agents. On the other hand each library might act as an agent for electronic journal packages produced by publishers, though I suspect this might be an interim scenario. The library might continue act as the negotiator for electronic subscriptions on behalf of the institution in much the same way as it does now. On the other hand it might prove more acceptable for regional or national agents (libraries, subscription agents ?) to hold the electronic store - someone is going to have to keep the archive - and sell single items rather than subscriptions. Libraries are even now in competition with other agents with regard to document supply and those agents are themselves jockeying for position. Even now a link up with the British Library and the search facilities at Bath Information Data Services will provide documents (not electronically at the moment) more or less at the stroke of a single key and the typing in of your Visa, Access, Mastercard number.

Most of us can recognise the attraction of these types of service to our clients. It is easy, you do not have to make a note of the reference and type it out on a form (or screen) for your local library. There are no tedious notes telling you that the item you requested is in the library and that you can photocopy it yourself (politely put of course!). The thing will somehow miraculously arrive on your desk. It probably will since there will be no mistakes in the reference. There will however be the little matter of cost. In a truly all-electronic world things may be different, but in the meantime the library may still have a role in saving departments and individuals money. It is important, however, that we realize that we have competitors in this changing world - our services will have to change and we should be thinking of value-added services or relinquishing this role to some other agent.

Although the publishers of conventional journals have concentrated on document delivery, there have been a few experiments with wholly electronic journals. The Online Journal of Current Clinical Trials has been set

up as something of an experiment by the American Association for the Advancement for Science. It is the first refereed, fully electronic journal in medicine. Its success in attracting articles to date has not been good and, I think, largely attributed to the fact that researchers need to have their articles published in journals with a recognized reputation. The new form of journal is of uncertain status. This must be one of the hurdles that electronic journals will have to overcome if they are to attract subscriptions. In the U.K. a recent report on libraries in the Academic sector has stated that articles in refereed journals - whether they are electronic or not should be counted as valid in research reviews of the institutions or personnel concerned. It may take time for the scientific community to value journals despite the medium, but I suspect it is only a matter of time, if the funders of research are prepared to accept them.

The real jokers in the pack are the bulletin boards and electronic newsletters which have blossomed all over the electronic networks. Whatever the subject you can join a relevant list, group, bulletin board and acquire free of charge up to the minute information, important data, fast feedback, and complete rubbish. Is this going to be the way forward for electronic journals ? To some the idea of cutting out the publisher and allowing all members of the electronic group to comment on (referee) the papers presented, is the solution to the "greed" of publishers and the drawbacks of the present refereeing system.

Some electronic publications of this type raise other issues. There is one very important Bulletin Board in high energy physics - a field that is expanding so fast that normal publication delays are seen as almost insupportable. The papers presented have all been accepted for publication by a journal, but they can be read free of charge by anyone, who joins the Bulletin Board. One of the problems (for the publishers) in all this is copyright. At the moment the networks are free at the point of use, but their maintenance and development have

considerable costs. Copyright is concerned with both revenue and in the integrity of the work. It is worth noting that the Institute of Physics is not permitting the transmission of its publications in electronic form. This may be a hinderance to communication, but does highlight the necessity for progress on a world wide acceptance of enforceable copyright agreements, if electronic journals are to serve the research community effectively.

The subject is enormous and trying to divine the future of scientific communication at this time is more akin to dreaming than the hard realities of our largely book-bound world. I have looked at some of the aspects which have caught my attention, but this is a Newsletter - not an authoritative review on the subject. For libraries and librarians it will surely mean change - radical perhaps but maybe not too rapid. We have skills that can facilitate the change, we maybe need to develop others, but above all I believe that we should have faith in ourselves and our skills in the management of information.



### African Index Medicus

*L'Index Medicus Africain: depuis 1990 a été lancé l'Index Medicus Africain avec la participation d'instances locales africaines (AHILA par exemple), mais également la National Library of Medicine à Washington et l'OMS. African Index Medicus (AIM) is a regional database of bibliographical records, some with abstracts, of health material published in or related to Africa. It comprises periodical articles, books, reports, theses, health learning

materials, etc. since 1990. It is composed by the merging of national databases, complemented by downloaded records from existing sources. In this connection AHILA warmly thanks the US National Library of Medicine for the relevant bibliographic records from the MEDLARS database. Bibliographical records from WHOLIS (the WHO headquarters Library database) are also included, and those from other sources such as POPLINE will also be added at a future stage. As more institutions join the consortium of AIM partners, their bibliographical records will be progressively included.



## **MANPOWER MANAGEMENT**

Medicus will appear quarterly and contain only the entries sent by the national data-input sites to the coordinating centre at the WHO Regional Office for Africa.

The complete database which includes data from non-national sources is also available at the Library of the WHO Regional Office for Africa for ad hoc searching and printouts by country.

Each issue is composed of three parts: the bibliographical entries which are arranged in alphabetical order by country name and within that order, by author; a subject index and author index.

The bibliographic information included for each work consists of: record number, author, title, source (for analytical entries), imprint, collation, series, abstract, sub-

ject headings taken from the US Medical Subject Headings (MeSH).

As the African Index Medicus is at the moment the work of anglophone participatory sites, the title page, preface, etc. is written only in English. At a later date when francophone and lusophone African countries and partners join the project, the documentation will also be produced in those languages.

The 4th Congress of AHILA (our African equivalent) is being held in Uganda from 25th - 29th April, at Makerere University, Kampala. We hope to have a report from this Conference in a subsequent issue.



## *Letters to the Editor*

### **Comments on the Newsletter**

Eleven replies to the questionnaire on the Newsletter are not an adequate sample to base far-reaching decisions, but they are of interest to the Editorial Board and I have reproduced them here, so that YOU can make further comments in a "Letter to the Editor".

A brief analysis showed that all the sections were rated as no. 1 (the most interesting) by someone. Though one or two respondents clearly felt that a number of the sections were equal in this respect. The longer articles and "News from Europe" were the two sections which commanded the most support, but that is as far as I am prepared to take the analysis.

More interesting and useful were the comments we received in the open questions regarding the introduction of new sections or general comments on the Newsletter and I have listed them here in the hope that it might inspire some of you to add to the debate.

#### **Format and general**

- Abstracts fall short of mentioning all the salient points;
- There are too many proof reading errors;
- Regret over the passing of the illustration on the front cover;
- Positive support for dual language;
- The interleaving of the two languages breaks concentration;
- Expand official languages or make regional editions of the Newsletter.

#### **Comments on existing sections**

- The News section should have better coverage;
- Articles which describe the automation of small medical libraries would be welcome as would collection policies with particular regard to older books; and items about innovations, which could be put into practice in a large number of libraries;
- Reference Books for Europe should not be restricted to European texts;
- More detailed information about educational courses to be held in Europe.

#### **New sections requested**

- Profiles of people on the Board, Council and Committees;
- Letters to the Editor (replies or comments on items in the Newsletter or its content, format as a whole);
- Informative advertising of new products, upgrades to existing services and new services (written by the producers);
- Members' advertisements - jobs etc.
- Index

#### **Comments from the Editor**

As retiring editor, I shall comment on those items, which I feel to have been my responsibility. The Editorial Board will address most of the issues at its next meeting, but would be grateful for any further ideas or opinions from you.

The illustration on the cover was replaced by a more informative list of contents. The Editorial Board agreed that this was a desirable development at its last meeting in Montpellier. Since the other covers are premium advertising space for our

sponsors (to whom we owe much), the list of contents had to appear on the front cover, which unfortunately left no room for a picture. Nevertheless it does raise the whole question of illustrations, which is something that will be discussed at the Editorial Board meeting.

The present policy with regard to language is in accordance with that of the Association, and though we will look at the suggestions made in this respect, the Newsletter is committed to publishing in the two official languages. At present only the Editorial and News from our Association are translated fully. Longer articles have abstracts, and the other, shorter items have what we hope are "informative title translations". The burden of translation, abstracting and proof reading falls heavily on only two people at present. As the Newsletter becomes more mature, I very much agree that we should adopt a more professional attitude to shortcomings in these areas. It is an organisational problem which the Editorial Board will have to address with the other suggestions that have been made.


