

## EDITORIAL

The Second European Conference of Medical Libraries has been a very large success: because of the numerous participants, more than 550, coming not only from the European countries, but from other continents (American, African, Asian and Australian colleagues came to Bologna as well). We had a remarkable opening session where Dr Stephen Lock, Editor of the British Medical Journal gave his keynote address about "The Professionalisation of Information". A welcome speech was presented by Prof. Francesco Pocchiari, General Director of the Istituto Superiore di Sanita. All the participants had the special opportunity to attend a plenary session about the CEC Action Plan, where Mr. V. Parajon-Collada, CEC Deputy Director General, presented the Plan and collected remarks and suggestion from a panel and the session participants.

Before the Conference, 54 librarians participated in 4 continuing education courses organized by our Association; questionnaires evaluating the courses have been collected and already discussed by the Executive Board in order to improve and develop a continuing education plan. The European Medlars Centres Meeting took place before the Conference as well, with the participation of Lois Ann Collaiani, Director of the National Library of Medicine. We had also the opportunity to visit an interesting and "hi-tech" exhibition of 31 firms presenting their new products: the bright premises allowed a very attractive arrangement, reminding the Bologna' porticos.

We are very glad to thank again the Soprintendenza per i Beni Librari della Regione Emilia Romagna, which is the major sponsor of our Conference (contributing with nearly a third of the total Conference budget) and whose organizational support was fundamental for the Conference success and the EAHL Meetings. Financial contribution of the Commission of the European Communities and the Direction des Bibliothèques, des Musées et de l'Information Scientifique et Technique (DBMIST) are to be reminded and thanked as well.

The Conference was also the occasion for the First General Assembly of our Association, the Meeting of the new elected Council and Executive Board. I am particularly glad to present the new Board to all members:

ACTIVITY REPORT OF EAHIL EXECUTIVE BOARD FOR 1987 AND 1988 PRESENTED AT THE GENERAL ASSEMBLY HELD IN BOLOGNA ON NOVEMBER 3, 1988

After our European Association for Health Information and Libraries was officially founded on 18 August 1987 in Brighton, it had to be carried out.

## RAPPORT D'ACTIVITES DE L'AEIBS

RAPPORT D'ACTIVITES 1987-1988 DU BUREAU EXECUTIF PRÉSENTE À L'ASSEMBLÉE GÉNÉRALE TENUE À BOLOGNE LE 3 NOVEMBRE 1988

Après la fondation officielle de notre Association Européenne pour l'Information et les Bibliothèques de Santé, le 18 août 1987 à Brighton, il a fallu l'établir pratiquement.

## SECRETARIAT

A part-time bilingual secretary has been appointed from September 1, a small office has been rented and furnished, and a PC and other equipments have been bought.

## LEGAL STATUTES

Our statutes have been recognized by the Belgian Ministère de la Justice and published in the Belgian Official Journal, on April 21. Our Association has now the legal statutes of international non governmental organization under the Belgian law which is one of the most favorable statutes for such bodies.

## MEMBERSHIP

A press release announcing the foundation of our Association has been distributed throughout Europe with membership applications. Our membership has increased from 74 in August 1987 to nearly 500 members in 15 months' time. On October 15, we had: 438 full members from 20 countries of the Council of Europe, 18 associate members from other countries on 5 continents, 8 affiliated members. 282 of our membership are individual members, 166 are institutional members and 8 are national library associations.

## REPRESENTATION

Our European Association has been invited and represented in several meetings since its foundation :

- the annual meeting of the Medical Health and Welfare group of the (British) Library Association in September 1987 and 1988
- the 2das Jornadas de Documentation Biomedica in Barcelona and the Meeting of German Medical Library Group in October 1987
- the 2nd Nordic Meeting for Medical Librarians in Stockholm in April 1988
- the Annual LIBER Meeting in Copenhague in July 1988
- the Annual Meeting of IFLA in Sydney in August 1988
- the Meeting of Czechoslovak medical librarians in Bratislava in October 1988.

The World Health Organization (WHO) and the Council of Europe have been asked to grant consultative statutes as non governmental organization, but it will not be given before two years have elapsed since the foundation of the Association.

## SECRETARIAT

Une secrétaire bilingue a été engagée à mi-temps le 1er septembre 1987, un petit bureau a été loué et équipé, un microordinateur et d'autres équipements achetés.

## STATUT LEGAL

Nos statuts ont été reconnus par le Ministère belge de la Justice et publiés au Journal officiel belge. Notre Association a désormais le statut légal d'organisation internationale non-gouvernementale de droit belge, l'un des statuts les plus favorables pour de telles associations.

## ADHESIONS

Le communiqué de presse annonçant la création de notre Association a été distribué dans toute l'Europe avec des formulaires d'adhésion. Ainsi notre Association est passée de 74 membres en août 1987 à près de 500 actuellement, 15 mois plus tard. Le 15 octobre 1988, nous avions : 438 membres de plein droit de 20 pays du Conseil de l'Europe, 18 membres associés d'autres pays des 5 continents, 8 membres affiliés. 282 membres sont des membres individuels, 166 sont des membres institutionnels et 8 sont des associations nationales de bibliothèques.

## REPRESENTATION

Notre Association européenne a été invitée et représentée à plusieurs réunions depuis sa fondation :

- la Réunion annuelle du Medical Health and Welfare Group de la British Library Association en septembre 1987 et 1988,
- les 2das Jornadas de Documentation Biomedica à Barcelone, et la Réunion du German Medical Library Group en octobre 1987,
- le 2nd Nordic Meeting for Medical Librarians à Stockholm en avril 1988,
- la Réunion annuelle de LIBER à Copenhague en juillet 1988,
- la Réunion annuelle de l'IFLA à Sydney en août 1988,
- la Réunion des bibliothécaires médicaux tchécoslovaques à Bratislava en octobre 1988.

Nous avons demandé à l'Organisation Mondiale de la Santé (OMS) et au Conseil de l'Europe de nous accorder un statut consultatif d'organisation non-gouvernementale, mais celui-ci ne pourra nous être accordé que deux ans après la fondation de notre Association.

However, our Association has already been recognized by the Commission of the European Communities (CEC) who officially asked for our comments about its draft CEC Action Plan for Libraries.

#### NEWSLETTER

As scheduled, we published our Newsletter in December 1987, March, June and September 1988. From March 1988, it has been printed with advertisements and mailed post free by EBSCO. This Newsletter of 20 to 24 pages is reproducing news of interest for European health librarians from all parts of the world, but most of those news are still written by Board members or especially requested by our secretary. Our Newsletter is also reproducing the contents of some six major library journals for European health librarians.

#### EDUCATION

Besides information, continuing education is one of the main objectives of our European Association, and we have announced in our Newsletter five traineeships abroad. Thanks to Monique Cleland, we also organised on 2 November 1988 four excellent continuing education courses with the participation of more than 50 colleagues.

#### EUROPEAN CONFERENCE OF MEDICAL LIBRARIES

The organization of our 2nd European Conference of Medical Libraries in Bologna has formed a major part of our Board members' activities since 1987, especially for Valentina Comba who represented our Association on the Local Organizing Committee, for Ursula Hausen, who chaired the Programme Committee and for myself who chaired the European Organizing Committee. We successfully obtained the support of top level representatives of WHO and CEC: Dr Rochon, Director of WHO Programmes in Europe, and Mr Parajon-Collada, CEC Deputy Director General, who will participate to the two plenary sessions of our Bologna Conference.

As a result of the intensive work of the three organizing committees, over 100 papers have been proposed and the presented papers will be published in our Proceedings thanks to the sponsorship of Swets and Zeitlinger, The Netherlands.

With over 550 participants from the five continents, the success of this 2nd European Conference of Medical Libraries is obvious. It is by far the largest Meeting of European librarians to date. Thanks to our Italian colleagues, the very large exhibition will be of great interest in our professional activities and this very

#### BULLETIN D'INFORMATION

Comme prévu, nous avons publié notre Bulletin d'Information en décembre 1987, mars, juin et septembre 1988. Depuis mars 1988, il est imprimé avec publicité et expédié par EBSCO, sans frais pour l'Association. Cette Newsletter de 20 à 24 pages publie des nouvelles du monde entier intéressant les bibliothécaires européens de la santé. Toutefois, la majorité de ces nouvelles sont toujours écrites par les membres du Bureau ou spécialement demandées par notre secrétaire. Notre Newsletter reproduit également le sommaire de quelque six périodiques de bibliothéconomie les plus intéressants pour les bibliothécaires européens de la santé.

#### FORMATION

En plus de l'information, la formation continue est l'un des principaux objectifs de notre Association européenne, et nous avons annoncé dans notre Newsletter cinq possibilités de stage à l'étranger. Grâce à Monique Cleland, nous avons également organisé le 2 novembre 1988, 4 excellents cours de formation permanente avec la participation de plus de 50 collègues.

#### CONFERENCE EUROPEENNE DES BIBLIOTHEQUES MEDICALES

L'organisation de notre Deuxième Conférence Européenne des Bibliothèques Médicales constitua la plus grande part des activités des membres du Bureau depuis 1987, spécialement pour Valentina Comba qui représenta notre Association au sein du Comité Local d'Organisation, pour Ursula Hausen qui présida le Comité Programme et pour moi-même qui présidai le Comité Européen d'Organisation. Nous avons réussi à obtenir le soutien d'importants représentants de l'OMS et de la CCE : le Docteur ROCHON, Directeur des Programmes de l'OMS en Europe et Monsieur PARAJON-COLLADA, Directeur Général Adjoint de la CCE, qui participera le vendredi à nos deux sessions plénières.

Suite au travail intensif des trois comités organisateurs, plus de 100 communications furent proposées et toutes les communications présentées seront publiées dans nos Actes grâce au parrainage de Swets & Zeitlinger, Pays-Bas.

Plus de 550 participants des 5 continents confirment le succès de cette Deuxième Conférence Européennes des Bibliothèques Médicales. Elle est

attractive social events will contribute to strengthen links between colleagues throughout Europe and even beyond.

#### ELECTIONS FOR THE FUTURE

Last but not least, our interim Executive Board elected at the inaugural Meeting of 18 August 1987 in Brighton had to prepare the election of the national delegates in our Council and the election of the members of our next Executive Board, who will take office at this General Assembly.

For that purpose, our Board proposed by mail last March to all full members a procedure including the establishment of a Nominating Committee (whose members would be proposed in most of the European countries) to call for candidates, to organize those elections and count the ballot papers.

Our objective was to achieve a perfect democratic procedure without the intervention of Board members and candidates and to stimulate a large participation in order to give to our young European Association a new and dynamic team for the next two years.

Thanks to a strong interest in our European Association, national delegates have been nominated for our Council by all involved countries except Ireland, and we had 14 candidatures for the five vacant seats of the Board.

Despite this unusual procedure and the summer period, the participation was more than 60%. Valentina COMBA has been elected as President by 85% of the votes (153/179) and Ursula Hausen reelected as Board member with 77 % (134/179).

I wish to thank the candidates for their willingness to cooperate and I hope non elected colleagues will be active in the committees we have to set up for various activities of our European Association.

I also wish to thank the members of the Nominating Committee for their work, although I would like to point out that our Board, our secretary and myself have undertaken too much of their work due to the fact that on one hand this kind of task was new to most of them and on the other hand they had no opportunities to meet each others and had to work for the first time on electronic mail. However, I still believe this was the best way to organize elections in a European Association like ours and this experience will be of great help to our next elections.

#### ELECTIONS

Enfin, notre Bureau Exécutif intérimaire, élu à la Réunion de fondation du 18 août 1987 à Brighton, devait préparer l'élection des délégués nationaux de notre Conseil et l'élection des membres de notre prochain Bureau Exécutif qui entre en fonction aujourd'hui à cette Assemblée Générale.

A cet effet, notre Bureau a proposé, en mars passé par courrier à tous les membres de plein droit, une procédure prévoyant l'instauration d'un "Nominating Committee" (dont les membres devaient être proposés par la plupart des pays européens) pour faire l'appel aux candidats, organiser ces élections et compter les bulletins de vote.

Notre objectif était de respecter une procédure parfaitement démocratique sans intervention des membres du Bureau, ni des candidats, et de stimuler une large participation de façon à donner à notre jeune Association européenne une équipe nouvelle et dynamique pour les deux années à venir.

Grâce à un vif intérêt pour notre Association européenne, des délégués nationaux pour notre Conseil ont été proposés par tous les pays concernés, excepté l'Irlande, et nous avons recueilli 14 candidatures pour les cinq sièges vacants du Bureau.

Malgré cette procédure inhabituelle et la période estivale, la participation fut de plus de 60 %. Valentina COMBA fut élue comme Présidente par 85 % de voix (153/179), et Ursula HAUSEN fut réélue comme membre du Bureau avec 77 % des voix (134/179).

### CONTINUING EDUCATION COURSES IN BOLOGNA, NOVEMBER 2, 1988

In its program activities, EAHL has placed continuing education very high on its list of priorities. Therefore, it was encouraging to see that the continuing education courses which were organized in the context of the 2nd European Conference of Medical Libraries, in Bologna, were very well attended with a total of 54 participants.

The course on MESH and NLM Classification Systems stressed various aspects of the NLM classification system and focused on the assignment of MESH headings in the cataloging process. The arrangement of tree structures and how it may be used in the cataloging process received also much attention. Management is the basis of all activities. In the complex environment of libraries long range planning, strategic planning and tactical planning must be part of management. A careful analysis of the environment, of goals and objectives, and evaluation of results and products are all part of

Dans son programme d'activités, AEIBS a mis l'accent sur les cours de formation continue. C'est pourquoi la réponse très positive à l'organisation des cours de formation de Bologne a été très encourageante, puisque 54 participants se sont rencontrés à Bologne, le 2 novembre pour ces cours.

Le cours sur la classification NLM et l'indexation MESH a souligné divers aspects de cette classification ainsi que l'utilisation des mots MESH pour l'indexation, lors du procédé de catalogage. L'aspect contrôlé, structuré et hiérarchique du vocabulaire MEESH a été longuement discuté.

Le management est le fondement de toute activité. Dans l'environnement complexe des bibliothèques, la planification à long terme, la planification stratégique et tactique font partie intégrale du management. Une analyse détaillée d'un environnement, des buts, des objectifs fixés, une évaluation des résultats et des produits sont

a methodology which must be learned. In time of constraint as well as in time of plenty, costs management are a most important part of effective management. Though it seems that it would be easy to learn a few formulas and rules of accounting and become an effective manager, in fact, a whole methodology and fundamental principles must be learned to be able to face a variety of situations and circumstances. The course on managing the cost effective library tried to answer this need.

Through the course on microcomputers in libraries, participants have shown that their competence in microinformatics should not be underestimated and that many libraries are now quite comfortable in the micro environment. Such a course should, in the future, address the question of microcomputers applications to the library world and perhaps deal with evaluation of existing systems.

EAHIL had planned to offer courses in all three official languages of the Conference, but the courses in French and Italian had to be cancelled for lack of a sufficient number of participants, at the closing date of registration for the courses. Though language did not seem to be a problem for those present, several people deplored the fact that the French and Italian courses had been cancelled. Simultaneous translation does not seem to be appropriate for courses if one wishes to preserve active participation and spontaneous interaction during the course. Therefore, EAHIL will try again on future occasions to present courses in at least 3 different languages.

Evaluation questionnaires which were returned by participants to the courses were quite informative. Several participants indicated that they favor courses on techniques or solutions directly applicable in their daily professional environment. In the same context, participants indicated their interest in having courses taught by professionals in the field, as opposed to specialists in other fields. The two courses on management in health libraries and on managing a cost effective library were well received and participants evaluation show that courses on principles and methodology are important and should definitely be kept in a program of course.

In all, the program of continuing education courses was a rewarding experience. EAHIL is ready to carry this effort further. Anyone interested in participating directly in the work of planning such programs should contact Monique C. Cleland, BDFM, CHUV BH 8, Lausanne 1011, Switzerland.

Dans les périodes de vaches grasses comme dans celles de vaches maigres, le contrôle du coût d'une opération est impératif. Bien qu'il semble être aisé d'apprendre quelques formules et de les appliquer pour devenir un manager habile, en fait, toute une méthodologie et des principes fondamentaux doivent aussi être appris. C'est ce qu'a essayé de démontrer le cours sur le management efficace des coûts d'opération d'une bibliothèque. L'accent portait plus sur des méthodes que sur des formules applicables ou des solutions toutes faites d'où le caractère peut-être un peu théorique du cours.

Il ne faut pas sous-estimer les connaissances en micro-informatique des bibliothécaires des années 80. Un groupe de participants déjà très bien informé en micro-informatique s'est retrouvé pour le 4ème cours. Il est évident qu'à l'avenir, un tel cours devra adresser la question des diverses applications de la micro-informatique aux bibliothèques et offrir peut-être une évaluation des systèmes existants. Tout un programme!

AEIBS avait prévu d'offrir des cours dans les 3 langues officielles de la Conférence. Malheureusement, les cours en italien et en français ont dû être annulés, faute d'inscriptions en nombre suffisant au moment du délai imposé. Puisqu'il ne semble pas que la traduction simultanée est désirable dans le cadre de cours, AEIBS essayera à nouveau d'offrir des cours dans des langues différentes.

Dans l'ensemble, les questionnaires d'évaluation des cours étaient très intéressants. Plusieurs participants ont indiqué qu'ils aimeraient des cours sur des techniques particulières ou des solutions directement applicables dans leur environnement professionnel. De même, plusieurs problèmes doivent être abordés par des professionnels du domaine de la bibliothéconomie, de préférence à des spécialistes étrangers au monde de la bibliothéconomie. Les 2 cours sur le management ont été bien reçus et les évaluations indiquent clairement que des cours sur des principes et sur la méthode doivent faire partie de tout programme offert.

En résumé, le programme de cours de formation continue a été une expérience positive et enrichissante. AEIBS est prêt à poursuivre cet effort. ## READER'S MAIL

A bustling, multi-lingual atmosphere, crowded corridors, a galaxy of grey and green "kit" bags visible a kilometre away, halls with unfinished plumbing adding aquatic to the other audio-visual effects, a flexibly timetabled bus service, a cake of colossal dimensions...

Such are but a few of my many impressions from the Second European Conference of Medical Libraries which took place in Bologna, Italy,

November 2-6, 1988. Europe has certainly extended its frontiers since my school days as colleagues from New Zealand, the USA and Mexico added an inter-continental flavour to the meeting. The Conference was held at the imposing Istituti Ortopedici Rizzoli Congress Centre, perched proudly on an outer city hill top. Language presented some of us with problems, most exchanges being conducted in Italian. However, the expertise of the translators made light of this problem and the inevitable queues for registration, headphones, lunch etc. proved conducive to trying out one's linguistic skills.

The theme "Health Information for All - a Common Goal" was liberally interpreted: papers covered a wide range of subjects from health education, database creation and document delivery to regional co-operation, CD-ROM applications and a marathon session on the "Action Plan" for libraries in the European Community. Papers reflected the range of experiences from "one-man-band" to large national collections.

As a backdrop to discussions on the practical, everyday problems and their solutions, the "Plan of Action" for libraries in the European Community is a concerted attempt to bring together our diverse experiences and to standardise our many practices with a view to closer European co-operation in the area of health information, both personally and electronically.

I was staggered to learn that there are some 75,000 libraries in Europe spending 5 billion ecus and containing approximately 1.2 billion volumes. The Plan of Action offers us the prospect of easier access to, and better use of, our extensive, often expensive resources.

Of the many interesting papers I attended, three were particularly outstanding. Donatella Ugolini outlined the changing pattern of biomedical information demands in the biomedical library of the National Institute for Cancer Research, Genoa, and spoke to her audience, seemingly without notes. The translators and I appreciated the beautifully clear enunciation of Madeleine Wolff-Terroine (Pegasos, Paris) when outlining the production of a new database devoted to drug addiction, TOXIBASE. Finally, Gosta Tibblin had his audience rapt with an example of a video newsletter for GPs, produced by the Family Medicine department of the University of Uppsala.

It was very reassuring, and a salutary reminder, that so many of our problems are universal, whether we are practising in the UK or the Socialist Republic of Serbia. The solutions, ideas and strategies-for-coping of others provided much valued encouragement, and food for thought, for delegates to take away from this stimulating and interesting exchange of ideas.

medical libraries have already bought POLYDOC MICRO, and started creating their own on-line catalogues. Just before setting forth for Bologna, the Group had its General Assembly in connection with the General Assembly of the Danish Union of Librarians.

The report of the year showed increased activities, e.g. demands for better salaries in the "one-man-band-library" and consultative tasks, several librarians involved in implementing new technology, participation in conferences in Sweden, Italy as well as in Denmark, representation in the EAHIL Council and other associations.

The Executive Board (Hanne Christensen, Alice Norhede, Elisabeth Oksholt) presented a small folder, aimed at attracting members to the Group. Work programme for the year 1989 includes a NLMC workshop, draft proposals for continuing education, and participation in a Danish Conference of librarianship with posters and papers concerning nursing libraries and libraries for paramedical staff. The Group now has 40 members, actually a 15% increase in a year.

8 members of the Danish Group of Medical Librarians went to Bologna to meet their European colleagues at the 2nd Conference of Medical Libraries. All Danish participants want to express their gratitude to Marc Walckiers, past President, for his invaluable contribution to initiating the EAHIL. Without his energetic and enthusiastic work, the Association would not have been such a success already.

8 membres du Groupe Danois des Bibliothécaires médicaux ont participé à la Deuxième Conférence Européenne pour les Bibliothèques Médicales à Bologne en vue d'y rencontrer leurs collègues européens. Tous les participants danois désirent ici exprimer leur gratitude à Marc Walckiers, ancien Président, pour sa contribution inestimable au lancement de l'Association. Sans son apport dynamique et enthousiaste, l'Association n'aurait pas le succès qu'elle connaît actuellement.

## CZECHOSLOVAKIA

The Institute of Scientific Health Information in Bratislava, Slovak Socialist Republic, held its Conference Days of Scientific Information on Medicine, from 19-22 September 1988. Ursula Hausen, EAHIL Vice President, represented the European Association for Health Information and Libraries as guest of the Czechoslovak Medical Society J.E. Purkyné. These conferences are organized every 2 years by the Society's sections of scientific information and by their respective institutes for health and medical information in Bratislava and Prague. About 150 medical librarians and information officers from Czechoslovakia and about twenty guest speakers from Bulgaria, the DDR, Italy, Norway, Poland, Sweden, Switzerland and the USSR participated.

## TCHECOSLOVAQUIE

L'Institute of Scientific Health Information à Bratislava, République Socialiste Slovaque, a tenu sa Conférence "Days of Scientific Information in Medicine", du 19 au 22 septembre 1988. Ursula Hausen, Vice-Présidente de l'AEIBS, a représenté l'Association Européenne pour l'Information et les Bibliothèques de Santé, conviée par la Société Médicale Tchécoslovaque J.E. Purkyné. Ces conférences sont organisées tous les 2 ans par les sections de cette Société sur l'information scientifique et par leurs institutions respectives pour l'information médicale et de santé à Bratislava et Prague. Environ 150 bibliothécaires médicaux et professionnels de l'information de la Tchécoslovaquie et 20 orateurs invités de la Bulgarie, RDA, Italie, Norvège,

The first thematic round concerned organization, control and tasks of medical libraries and information centres in the system of health service. Examples were given in reports about WHO documentation, the system of scientific medical information in the USSR (A.S. Kiselev), activities of the Institutes for Medical Information in Bratislava and Prague (M. Lomenova and J. Peska) and on the work of several other centres in the country, as well as on economic factors in public health information in Bulgaria (A. Valchev). A paper by N.A. Lovenetski, All-Union Institute of Medical and Medico-Technical Information, Moscow, considered the marketing of MEDINFORM data bases outside Socialist countries.

A substantial part of the programme dealt with scientometric research in medicine, the application of computer technology in libraries and user education in research institutes, undergraduate and graduate medical training.

Our Czechoslovak colleagues extended their great hospitality to all their guests at a memorable evening in the old castle above Bratislava which now serves as a museum, at a reception by the mayor in one of the marvellously restored city palaces and at several musical events. This was one of the still rare events when European health librarians met with their colleagues from Socialist countries in a country of Eastern Europe for an exchange of professional views and experience.

Pologne, Suède, Suisse et URSS y participèrent.

Le premier thème de débat a été l'organisation, le contrôle et les tâches des bibliothèques médicales et centres d'information dans le domaine du service de la santé. Des exemples ont été donnés par des comptes rendus sur la documentation de l'OMS, le système d'information scientifique médicale en URSS (A.S. Kiselev), les activités des institutions pour l'information médicale à Bratislava et Prague (M. Lomenova et J. Peska), sur les travaux de plusieurs centres dans le pays, ainsi que sur les facteurs économiques dans le domaine de l'information de la santé publique en Bulgarie (A. Valchev). Une communication de N.A. Lovenetski, All-Union Institute of Medical and Medico-Technical Socialist Information, Moscou, a présenté le marketing des bases de données MEDINFORM en dehors des pays socialistes. Une partie importante du programme a traité de la recherche scientométrique en médecine, de l'application de la technologie en bibliothèque, de la formation des usagers dans les instituts de recherche et des stages d'étudiants et gradués en médecine.

Les collègues tchécoslovaques ont prolongé leur hospitalité par une soirée mémorable dans un vieux château situé au-delà de Bratislava qui sert actuellement de musée, par une réception offerte par le Bourgmestre dans l'un des palaces merveilleusement restaurés de la ville et par plusieurs manifestations musicales. Cette Conférence a été un des trop rares événements où les bibliothécaires européens de la santé ont pu rencontrer dans un pays de l'Europe de l'Est leurs collègues des pays socialistes dans un but d'échange d'expériences et de vues professionnelles.

## FRANCE

**REDATEL (Rehabilitation Data Telematics System)** - Database in the field of rehabilitation of physical handicaps.

The first section of this database, bibliographic data RED 1, has been available since February 15, 1986 on GCAM. Produced by a network of indexing centres at the national level, it includes references from 120 French and foreign journals, reports from congresses, monographies, university surveys, etc. The references go back to 1973. Up to now over 30,000 references are on-line with monthly updating (some 300 references). The costs for accessing the database amount to FF 5.80 per minute of connection (usually 5-6 minutes). The REDATEL System has 3 additional databases (legal, technical and socio-professional). Access and password can

#### F. R. GERMANY

On September 26-29 the University Library Essen, that is Dr. Helal, has held  
the 11th Anniversary Essen Symposium. More than 80 specialists from over  
the world were guests for this event.

On the theme "The Impact of CD-ROM on Library Operations and Universal  
Availability of Information" 15 lectures were given to the participants.  
One day was dedicated to the ADONIS project. Andrew Braid, the British  
Library, Boston Spa, described the project and the production cycle for  
ADONIS article identification number and the workstation used for retrieving  
articles. Ulrich Korwitz, Cologne gave a paper on the first experiences in  
the Medical Central Library. This Library is one of the libraries  
participating in the ADONIS project since spring 1988.

As the national document supply centre for biomedicine in the F.R.Germany  
the Library expects to gather experience in the use of new technologies,  
especially CD-ROM, in a rather conventional working process, the supply of  
photocopies of journal articles. Moreover, Ulrich Korwitz compared the  
positive aspects with negative aspects.

Positive aspects:

- no binding needed, no missing material
- good print-out quality of photos
- physical strain is reduced.

Negative aspects:

- no index-search
- time lag, supplements partly missing, no loan of complete issues possible,  
no colour photographs.
- There are more aspects regarding a future situation without printed ADONIS  
journals:
  - No subscription costs for ADONIS journals;
  - no costs for binding ADONIS journals;
  - Space saved in the stacks;
  - DOCMATCH project: immediate supply of documents.
- No possibility of working when the system breaks down;
- complete confidence in the system - no control possible;
- Only 1 user at the station compared to many in the stacks;
- No browsing in printed issues or indices possible.

David J. Brown, the Blackwell Group, Oxford talked over "ADONIS - The  
Strategic Needs of Publishers". ADONIS had its inception in the 70's when  
publishers expressed their concern about the impact the photocopying of  
articles was having on periodical acquisitions in research libraries. After  
a number of inconclusive studies and open debates in the UK library trade  
journals between publishers and librarians, Elsevier and a group of other  
publishers and librarians, looked jointly at the possibilities of new  
technologies providing another source of income to publishers through the  
creation of "separates" publishing in completion with photocopying. The  
history of ADONIS itself has shown many changes in philosophy and technical  
design, but the current pilot project is a basis for evaluating how  
publishers and librarians may work together to create a new information  
system for the future.

The other sessions were also about CD-ROM:

- CD-ROM and access to information in Southern countries;
- electronic publishing developments, by OCLC;
- Science Citation Index on CD-ROM;
- CD-ROM and library cooperation, by LIBER General Secretary;
- CD-ROM catalogue in a PC-network;
- Dutch reference files on CD-ROM, by PICA;
- German libraries on CD-ROM;
- National bibliographies on CD-ROM: a European project.

The Meeting programme was very interesting and included a very good commercial exhibition.

## ITALY

Recently Italian researchers belonging to the Society for Applied Pharmacological Science (S.S.F.A.) set up a group interested in laboratory animal science, known as the: "Gruppo Italiano di Scienze dell'Animale da Laboratorio" G.I.S.A.L. "Italian Group for Laboratory Animal Science". This group is developing an educational program through which it hopes to help reduce the use of animals by optimizing experimental conditions and by a constant search for valid alternative methods. In this effort G.I.S.A.L. plans to join forces with similar European and American organizations.

The Group's practical aims are to bring Italy into line with other developed countries as regards the use of animals in research; to encourage application of international regulations concerning the use of animals in experiments; to offer educational and updating schemes for students and researchers in biomedicine in Italy, to disseminate information on laboratory animal science through a pertinent references list.

The Gustavus Pfeiffer Memorial Library of the Mario Negri Institute in Milano, has therefore drawn up a catalogue of 315 books on animal cares available in 5 libraries of research institutes and 11 libraries of pharmaceutical companies. In order to keep the catalogue continually updated, we invite other libraries to submit their lists for inclusion, and to keep us advised of changes and additions. The list will be useful to researchers in biomedicine, to students and recent graduates in this and related fields, to laboratory technicians and to all those working -or planning to work - with animals in their investigations that should be well documented on questions related to laboratory animal science.

Rossi) to discuss the Working Item 115 "Standard Technical Report Number - Format and Creation" and submit a proposal. At present a revised draft, circulating among the members, is going to be considered and will be presented for acceptance to the SC9 Meeting (Washington, May 1989).

TOEFL examination with a score of 600 or above is required.


