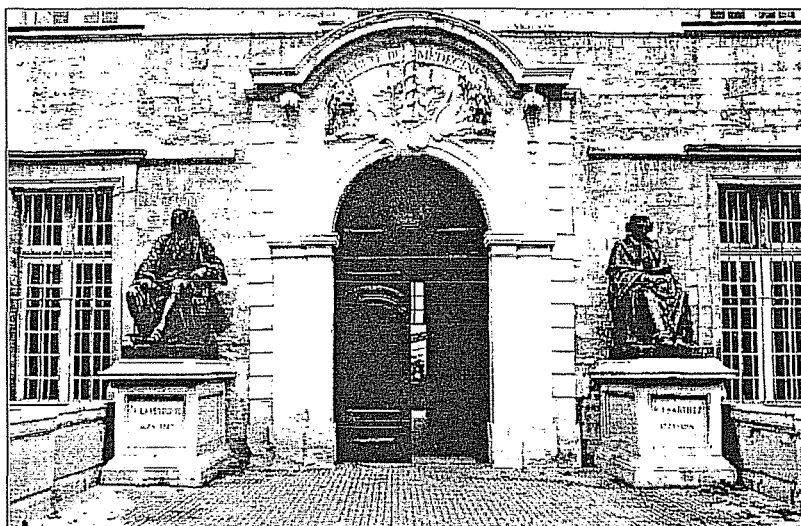

EDITORIAL

Human Networks

Two recent events have prompted the subject of this editorial at this time. One was the request for help and support that we had from Zagreb and the other was an article in the journal "Nature" (Lond). They both in their different ways make it painfully obvious that some libraries are labouring under difficulties, which most of us in western Europe, can hardly imagine. We all have our difficulties. The invited article from our Spanish colleagues describes some of their particular problems and it is interesting that the "human network" seems to be one of the most effective ways of changing things for the better.

When we first received the fax from Zagreb asking for information on the treatment of war casualties, my mind went back to January of this year. The Gulf War was imminent. With sinking hearts we faced the appalling possibilities of war casualties - conventional, chemical and biological. Our hospital was to be one of the receiving hospitals, but we had no books on the treatment of modern war casualties. The human networks of health and medical librarians communicated using e mail and personal contacts. I remember this being a great comfort. If I missed something - someone else would probably pick it up and let me know about it. We were of course immensely lucky in having contacts with the Medical Information Section of the British Library. They produced bibliographies and made special arrangements to make requests rapidly available to the receiving hospitals. Thus by the time the war started we were in a position to support medical, nursing and other staff with the information they needed.

Not everyone is in this happy position. Disaster can strike quickly. Human networks may not be in place and local resources may be inadequate to meet the specific need.

Problems of resources are not confined to "disaster areas". There are large parts of this world where resources are pitifully and chronically inadequate. Nevertheless the human network remains effective - see Monique Cleland's article (last issue) on the African Health Information Association. So what part should EAHIL or its members play? Most importantly, I suppose, we are a human network. That then poses the question of how members help one another. Meetings, workshops and so on encourage personal contacts; the EAHIL directory gives fax and telephone numbers; the newsletter is a means of exchanging information and ideas. That is OK as far as it goes. The human network can effect many things but it cannot replace adequate resources.

The article in Nature (*) addresses the problem of scarce resources in the poor countries of the south - physicists rather than physicians seem to have come up with some very practical ideas. An appeal was published by Physics Today urging libraries to donate their surplus (not old and unwanted) books; a professor of theoretical physics is co-ordinating the project and assessing the needs of developing countries; UNESCO is involved; some publishers are participating in the donation programme etc. Abdus Salam makes other suggestions, not all of which would I personally want to advocate, but the ideas might be built on and refined.

EAHIL itself can point to inequalities between countries and libraries. It is surely a part of our aims to support each other so that we can

EDITORIAL

Les Réseaux Humains

Ce sont deux évènements récents qui ont orienté le sujet de cet éditorial cette fois-ci. L'un d'entre eux a été la demande d'aide et de soutien reçue de Zagreb et l'autre, un article dans le journal "Nature" (Londres). De manière différente, ces deux évènements montrent qu'il est malheureusement évident que certaines bibliothèques fonctionnent sous certaines contraintes que la plupart d'entre nous, en Europe occidentale, sommes loin d'imaginer. Nous avons tous nos difficultés. L'article de la tribune libre émanant de nos collègues espagnols décrit quelques-uns de leurs problèmes particuliers, et il est intéressant de noter que le "réseau humain" semble être l'un des moyens les plus efficaces de changement vers du mieux.

Lorsque nous avons d'abord reçu la télécopie de Zagreb nous demandant de l'information sur le traitement des blessés de guerre, mon esprit revint sur les évènements du début de l'année. La guerre du Golfe était imminente. D'un coeur abattu, nous avons dû faire face à l'épouvantable éventualité des pertes de guerre, dues aux armements conventionnels, chimiques et biologiques. Notre hôpital devait être l'un des hôpitaux recevant les blessés mais nous n'avions pas de livres sur le traitement des blessés dus à la guerre moderne. Les réseaux humains de santé et les bibliothécaires médicaux communiquèrent par courrier électronique et contacts personnels. Je me souviens que tout ceci était un grand réconfort. Si quelque chose m'échappait, quelqu'un d'autre s'en rendait probablement compte et me le faisait savoir. Nous avons eu, bien sûr, énormément de chance grâce aux contacts établis avec la section information médicale de la British Library. Ils ont produit des bibliographies et ont fait des arrangements particuliers permettant une disponibilité rapide des demandes de prêt-inter pour les hôpitaux destinataires. Ainsi, lorsque la guerre a commencé, nous étions en

mesure d'apporter un soutien médical, infirmier et autre avec l'information nécessaire.

Tout le monde ne bénéficie pas de cette situation favorable. Le désastre peut frapper rapidement. Les réseaux humains peuvent ne pas être en place et les ressources locales peuvent être insuffisantes pour faire face à des besoins spécifiques. Les problèmes de ressources ne sont pas limités aux "zones de désastre". Il y a des parties importantes de ce monde où les ressources manquent pitoyablement et chroniquement. Le réseau humain y reste néanmoins efficace - voir l'article de Monique Cleland dans le dernier numéro concernant l'Association Africaine pour l'Information Médicale -. Quel rôle doit alors jouer l'Association Européenne pour l'Information et les Bibliothèques de Santé (AEIBS) ou ses membres ?

Je crois que, ce qui est le plus important, c'est que nous soyons un réseau humain. Ceci pose donc le problème de savoir comment les membres de notre Association s'entraident. Rencontres, ateliers, etc.. favorisent les contacts personnels; le répertoire de l'EAHIL/AEIBS indique les numéros de télécopie et de téléphone; ce bulletin permet échanges d'informations et d'idées. Tant mieux si cela peut continuer. Le réseau humain peut affecter beaucoup de choses mais il ne peut pas remplacer des ressources insuffisantes.

Quant à l'article de "Nature" (*), il soulève le problème de la pénurie des ressources dans les pays pauvres du Sud - des physiciens plutôt que des médecins semblent avoir eu quelques idées très pratiques sur ce sujet -. Un appel a été lancé par "Physics Today" qui invite vivement les bibliothèques à faire don de leur surplus de livres (ni les vieux livres ni les livres dont on ne veut pas); un professeur de physique théorique coordonne le projet et évalue les besoins des pays en voie de développement; l'UNESCO est impliquée dans ce projet; quelques éditeurs participent au programme de dons, etc. Abdus Salam fait d'autres suggestions que, personnellement, je ne recommanderais pas nécessairement dans leur ensemble, mais qui pourraient être reprises et réexaminées. C'est justement l'EAHIL/AEIBS qui peut être en mesure de souligner les inégalités entre pays et bibliothèques. C'est assurément l'un de nos objectifs que d'apporter un soutien mutuel à nos membres afin de répondre aux besoins de nos lecteurs, quelles que soient les circonstances. La première priorité de l'EAHIL/AEIBS est d'être pour ses adhérents mais nous ne voulons pas devenir exclusifs en nous tournant vers l'intérieur, ni oublier des besoins des autres.

Ce Bulletin a toujours essayé de vous apporter des nouvelles de l'extérieur de l'Europe mais jusqu'à présent ne les a pas recherchées activement. Contrairement aux autres rubriques de ce Bulletin, il n'y avait pas, dans ce secteur, de responsable de rubrique, mais maintenant que Liisa Salmi a accepté cette tâche, j'espère que nous serons en mesure de vous apporter une plus grande sélection d'articles intéressants, de différentes parties du monde.

Thursday was essentially occupied with the preparation of the "Call for Papers". This will be mailed in December 1991. The question of "Call for Papers" is of course closely related to the programme itself. Among the important decisions made were: the choice of French and English as the official languages of the conference; the inclusion of a live poster session; the emphasis which should be given to general discussion in the afternoon sessions of the Conference on Thursday and Friday.

A lively discussion occupied most of the Friday morning regarding the "Comité d'honneur", speakers to be invited, sponsorship, the exhibition, continuing education courses, publication of the summary and the full text of the communications presented. The programme committee continued this discussion on Saturday morning.

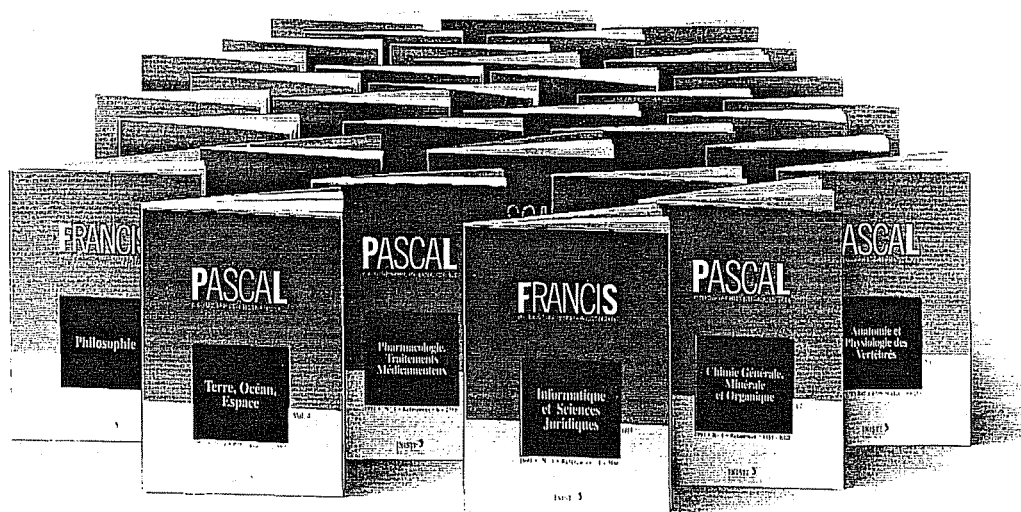


Informal Meeting with Council of Europe's Representatives

names. Meanwhile a first contact with parliamentarians of the Council of Europe has been made addressing the issue of the provision of health and medical information to health professionals at the sub-university level through hospital libraries.

The other main issue was what we in EAHIL, through our members, can do for the Council of Europe in matters concerning health and health information. There is concern on their part that their Recommendations are virtually unknown among all levels of health workers in the Member States. It was agreed that medical libraries would be a good outlet for such information. Beatrice Wilhelm who compiles the Publications Section will be informed about new Council of Europe documents and publications. It was also felt that reviews of important Recommendations might be published in the Newsletter and elsewhere. For instance a review of Recommendation nr.R (89) 13 "On the Organisation of Multidisciplinary Care for Cancer Patients" will appear in the next Newsletter.

Our application for being granted a Non-Governmental Organisation (NGO) status is proceeding. If there is no objection EAHIL should achieve this in the Spring of 1992.

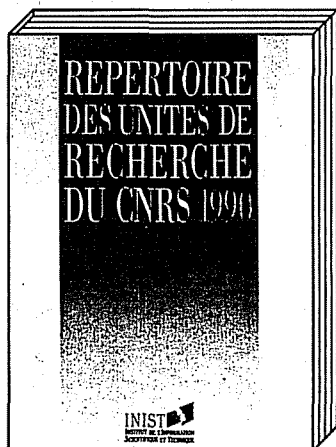

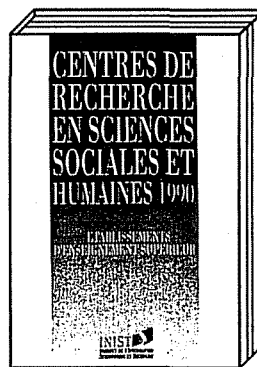

Health Science Libraries in Spain

Situation des bibliothèques médicales espagnoles

Les bibliothèques médicales espagnoles souffrent d'un grand éparpillement et d'un manque de coordination (ou de politique commune) entre elles. Toutefois, pour satisfaire le lecteur, il existe des réseaux humains de responsables de ces bibliothèques. Les personnels sont souvent peu ou pas qualifiés, les collections et les équipements inadéquats, ce qui implique, à quelques exceptions près, une qualité de service peu satisfaisante pour l'usager. Pas de catalogue collectif pour les ressources, pas de répertoire commun; donc, un recours constant aux services étrangers (BLDS, CNRS) malgré une collection bibliographique importante dans le pays. Sur 100 bibliothèques médicales seulement un tiers peut fournir des recherches bibliographiques sur CD-ROM. On a donc recours au réseau humain. Il n'y a pas d'associations professionnelles sur le plan national, seulement dans quelques régions (Andalousie). Toutefois, depuis 1986, trois réunions professionnelles ont pu se tenir, traitant du prêt-interbibliothèques, entre autres, et en 1992 une réunion est prévue dont le thème sera "Réseau humain". Les signataires font circuler un questionnaire dans toutes les bibliothèques d'hôpitaux pour obtenir des informations chiffrées sur leurs situations.

In Spain there are several types of Health Science Libraries (HSL), dependent on different organisations: universities, hospitals, associations, laboratories, etc. As regards the National Health Service Medical Libraries there is no institutionalised organisational structure: only a few timid approaches in some of the autonomous regions (Andalusia, Basque Country, Catalonia) where attempts have been made to establish standards for the running of these libraries.

This lack of a "planned" health information system, including bibliographic documentation and information services, has given rise to multiple problems :

- 1) preventing those in charge of libraries from developing their work adequately,
- 2) a lack of adequate information to the user,
- 3) dispersion of bibliographic collections leading to the increased cost of information services.

HSL are islands of information in which it is only the effort of those responsible for running them that provides the user with the information required. There are no information networks, but there are human networks.

Staffing

The majority of those working in HSL are not qualified. As library services are not specifically included in hospital staffing structures, most staff running these libraries do not have the necessary qualifications. This means that HSL are not able to offer the user that quality of service required for the user's three functions: medical care, teaching and research. With few exceptions, neither

the collections of these libraries nor the equipment are adequate.

Catalogues

There is no catalogue of resources covering all the libraries. Although there is a National Collective Catalogue, this does not reflect the reality of existing resources. The lack of a reliable directory means that there are no programmes of coordination and cooperation.

But in spite of all this, there is a "Human Network" which transfers medical and scientific information through the means available.

The lack of a directory and reliable collective catalogue, means that we continually need to use foreign information retrieval services (BLDS, CNRS, etc.), an unnecessary expense which could be avoided if the tools mentioned above were available. There is in fact a large bibliographic collection in this country.

Automation

As regards automation, only a few HSL are beginning to contemplate this possibility. Of almost 100 HSL, only one third provide an information retrieval service (CD-ROM). The most widely used database is Medline. It is interesting to note the tremendous success of CD-ROM compared to the minor use of on-line databases. The incorporation of CD-ROM into HSL has brought about significant changes, enabling the user to be given, in a few minutes, the information required. However, as we have mentioned, this technology has been introduced in only the larger and better equipped HSL.

The Human Network

There is no professional association at national level, although in some autonomous regions (Andalusia) groups have been formed recently.

The profession of Medical Librarian is not officially recognised. In 1986, the first Meeting for Biomedical Information and Documentation was organized; this allowed professionals to meet and make the contacts needed in order to set up unofficial coordination and organize non-institutional programmes of interlibrary cooperation, continuing education courses, etc. Since 1986, two further meetings have been held, and the 4th Meeting is planned for 1992. It is this "Human Network" that is struggling to make HSL work, in spite of everything, in Spain.

These problems are the basis of a study we are carrying out using a questionnaire sent to all hospitals libraries, aimed at obtaining reliable data on the state of these libraries in Spain.

La Bibliothèque de la Faculté de Médecine de Montpellier

The Library of the Faculty of Medicine in Montpellier

The Montpellier School of Medicine was founded in 1180. Virtually nothing remains of the earliest libraries though some medieval archives attest to their existence. The present library dates from 1767 when Dean Haguenot donated his own library (some 1200 works) to satisfy the needs of the students, who had been vigorously petitioning for such a facility. During the French Revolution (1794) this library was transferred to the new Ecole de Santé in what had been the Bishop's Palace.

In the early part of the 19th century, owing to the support of Professor Dumas and the diligence of the librarian, Prunelle, the collections were enriched by the acquisition of manuscripts from the 8th - 14th century (many illustrated), and printed books.

In 1885 a printed catalogue was completed by Gordon, the librarian. There were about 5000 volumes at this time covering not only medicine, but theology, philosophy, science, history and literature, but the library's autonomy was under threat. In 1879 it had become the "Medical Section" of the University library. After Gordon's death in 1895, the collections were dispersed to the different sections of the University Library. However in 1991 the original collection was brought together again in refurbished medieval surroundings, made available to them by Dean Solassol.

In 1986 the catalogue was automated using SIBIL and it is hoped that a mixed media library will be opened at the end of 1992.

Si l'Ecole de Médecine de Montpellier s'enorgueillit de remonter à 1180, sa bibliothèque ne peut se targuer d'une telle ancienneté. Il y eut bien - les archives médiévales que nous conservons en témoignent - quelques bibliothèques mais leurs fonds ne résistèrent pas aux diverses dégradations et aux guerres de religion notamment.

C'est en 1757 qu'une pétition d'étudiants réclame énergiquement "la fondation d'une bibliothèque publique à l'usage seul de la Faculté" et c'est en 1767 que le Doyen Haguenot (dont le buste de marbre blanc orne la salle de lecture) offrit sa propre bibliothèque (1200 ouvrages encyclopédiques) assortie d'un legs devant pourvoir au traitement d'un bibliothécaire. Lorsque la Révolution Française attribuera en 1794 les superbes locaux de

l'évêché à la nouvelle Ecole de Santé, on y transférera la bibliothèque du doyen Haguenot (déjà enrichie d'autres legs). Mais les professeurs de la nouvelle Ecole insatisfaits réclamèrent vite des fonds pour développer les collections.

Les ambitions de l'Ecole étaient vastes. Le Professeur Dumas en avril 1798 ne proclamait-il pas (Discours sur les progrès futurs de la science de l'homme) qu'il fallait "enrichir les bibliothèques de tous les livres qui attestent les progrès de la médecine" et ne pas "séparer la philosophie de la médecine" qui toutes deux rassemblent "les rapports qui lient l'homme à la nature". Chaptal, ministre de l'Intérieur, confiera à J. Vigarous puis à G. Prunelle la mission d'inspecter les dépôts littéraires créés après la Révolution. Chacun sait que le bibliothécaire Prunelle eut à coeur, de 1802 à 1807, d'enrichir Montpellier d'une prestigieuse collection de manuscrits mais aussi de milliers d'ouvrages imprimés. Parmi les 839 volumes manuscrits de la bibliothèque, on retrouve une majorité de manuscrits "littéraires" et religieux. On ne trouve que 170 manuscrits "médicaux".

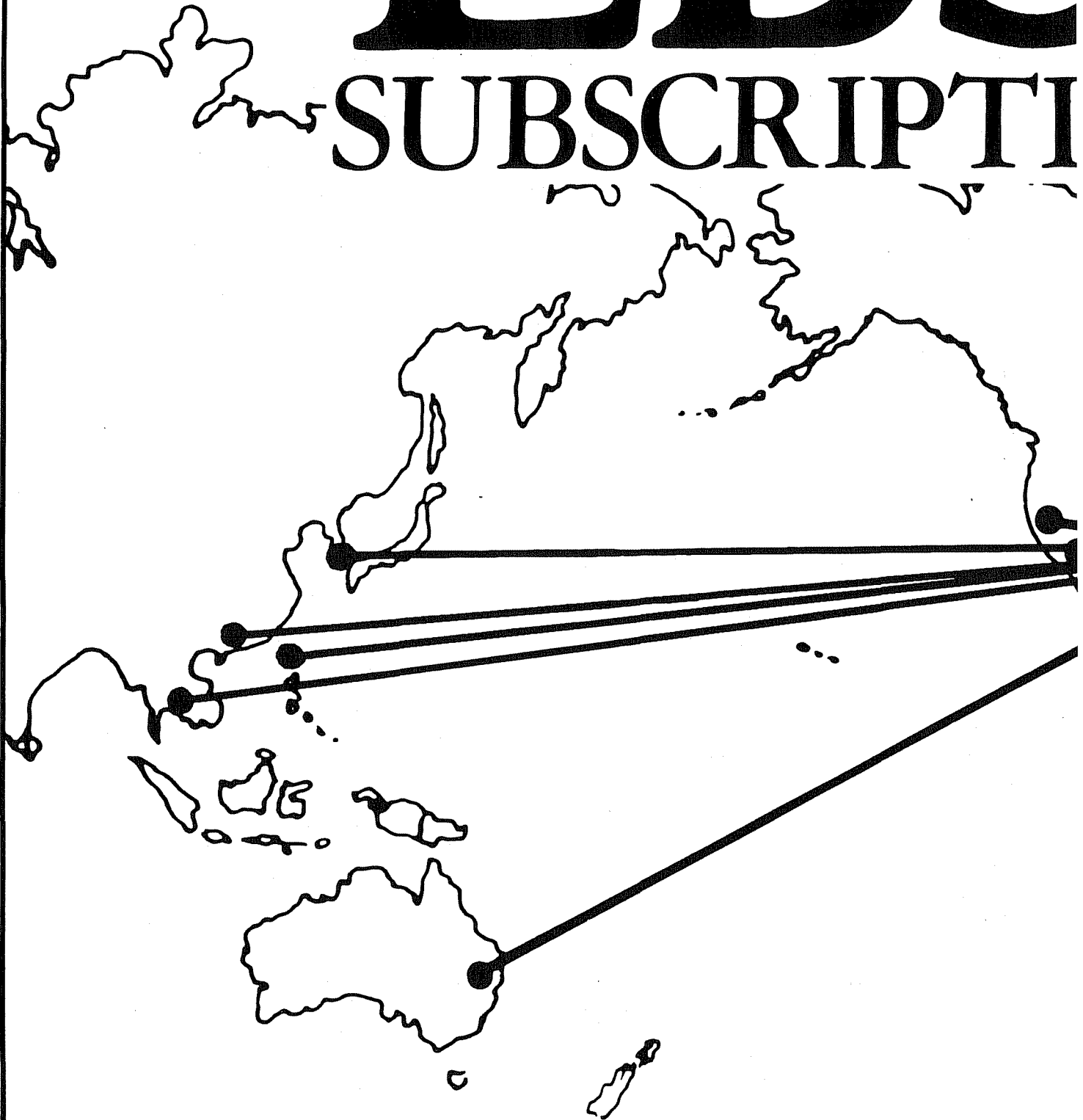
La richesse de la collection provient de la variété des collections, de leur ancienneté (un quart des manuscrits sont datés du VIIIe au XIIe siècles, un autre quart des XIIIe et XIVe siècles) et de la beauté des illustrations. Saisies, échanges et acquisitions lui permirent d'offrir à ses étudiants "une collection de tous les ouvrages de prix que la fortune ordinaire d'un particulier ne lui permet pas d'acquérir et tous les livres manuels qui peuvent être à l'usage des étudiants". Tout au long du XIXe siècle, les dons des enseignants de l'Ecole iront enrichir les collections.

Les locaux attribués à la bibliothèque furent l'objet des soins constants de la Faculté : réfection de la grande salle de lecture sous le décanat de Lordat, ouverture régulière de nouvelles salles pour l'entrepôt des collections.

Et pourtant, tout au long du XIXe siècle, les bibliothécaires doivent déplorer l'exiguïté et le peu de commodités des magasins, l'insuffisance de l'éclairage et le manque de personnel (un bibliothécaire, son adjoint, et un garçon de bibliothèque; un deuxième garçon de bibliothèque sera recruté à partir de 1848). De leur côté, les professeurs se plaignent du peu d'heures d'ouverture de la bibliothèque et des modalités de prêt! Les registres témoignent de l'attention que portaient les enseignants à leur bibliothèque (commission spéciale, professeur élu chargé de la surveillance de la bibliothèque, etc.). Un inventaire sera à nouveau décidé et imprimé en 1885. Ce fut l'oeuvre du bibliothécaire Gordon : il recensait environ cinquante mille volumes. La bibliothèque restait encyclopédique et les ouvrages

classés systématiquement dans les salles (A: philologie, orateurs et poètes; B : théologie, philosophie; C : mathématiques, physique, chimie; D : histoire naturelle; E : médecine; F : géographie, histoire; G : thèses; H : manuscrits; J : incunables; K : atlas; L : éditions de luxe; M : livres d'art).

Une autonomie menacée

Mais à partir de 1855 (création des bibliothèques des Académies regroupant celles des diverses facultés), l'autonomie de la bibliothèque se trouve menacée. L'énergique protestation de ses enseignants lui permet de conserver un temps ses collections et son indépendance. Si, en 1879, elle devint officiellement "section médecine" de la Bibliothèque universitaire, elle conserva ses locaux, ses fonds, et, en 1886 le règlement de la Bibliothèque universitaire rappelle que "le bibliothécaire de la section médecine jouira des droits et des prérogatives conférés au bibliothécaire de la Bibliothèque universitaire... et aura la même responsabilité". A la mort du bibliothécaire Gordon, en 1895, de profonds changements intervinrent. On nomma dès lors un bibliothécaire en chef à la Bibliothèque centrale, assisté de deux adjoints, l'un pour la section centrale, l'autre pour la médecine.

Jusqu'alors, les bibliothécaires et les adjoints, tous médecins mais aussi bibliophiles et érudits, avaient été recrutés par la Faculté; après 1895, ils le seront par l'administration centrale parmi les spécialistes en bibliothéconomie, quelle que soit par ailleurs leur formation universitaire. Les fonds de la bibliothèque de l'Ecole furent même un moment dispersés entre diverses sections de la bibliothèque universitaire. Mais l'incessante protestation des médecins, l'énergique activité du Doyen Solassol qui offrit en 1991 à la bibliothèque de nouvelles salles médiévales restaurées avec soin pour y regrouper les collections anciennes amenèrent l'actuelle directrice de la bibliothèque Maguy Pezeril à organiser le rapatriement des anciens fonds de l'Ecole de médecine, tous ornés du fameux cachet "H TEXNH MAKPH" (début du premier aphorisme d'Hippocrate).

Des kilomètres de livres et ... (quelques ordinateurs)

Toutefois les locaux de la bibliothèque malgré des prodiges continus d'extension et de réfection s'avèrent incapables de contenir l'essentiel de la production documentaire. En 1991, malgré l'ingéniosité du personnel et la politique d'élimination en cours, les huit kilomètres de rayonnages de magasins sont saturés. Les étudiants continuent à s'asseoir dans la belle salle style empire de l'ancienne école de santé. Seule une petite salle annexe a pu être ouverte et l'on peut y consulter les derniers numéros de périodiques et travailler sur les divers CD.ROM et vidéodisques déjà installés.

Des milliers de fiches décrivent les collections jusqu'en 1986. Depuis cette date, le catalogage est automatisé : la

bibliothèque fait partie du réseau SIBIL (Système informatisé pour bibliothèques). Dans la salle de lecture toujours décorée par les deux grands tableaux édifiants commandés par Lordat, sous les regards de Prunelle (huile sur toile) et du doyen Haguenot (buste en marbre érigé en 1768), les employés de la bibliothèque enregistrent les opérations de prêt sur des terminaux d'ordinateur. Si les bibliothécaires, tout comme les professeurs, ont cessé d'enseigner la bibliographie depuis 1880, les étudiants et les chercheurs peuvent, près du bureau sous les toits où Joseph Bonaventure Laurens recevait Liszt, interroger les grandes bases de données internationales; grandeur et misère de la bibliothèque de ce que Chaptal appelait en 1819 : "le plus beau et le plus ancien monument d'instruction que possède la France".

Mais de même que les collections anciennes retrouvent leur unité et un cadre digne d'elles, de même un chantier est ouvert depuis l'été 1991 et si tout se déroule heureusement une médiathèque moderne accueillera étudiants et chercheurs à la fin de 1992.

Purchasing Intelligence - Information for the Management of Healthcare The information needs of the District Health Authorities - the new "purchasers" of healthcare. A study day.

Achat de systèmes experts - Information pour la gestion des systèmes de santé. Les autorités régionales liées à la santé ont besoin d'une information adaptée : ce sont les nouveaux "acheteurs" de services de santé. Journée d'étude.

The separation of the responsibility for managing services and for identifying the need for different types of health care is a key principle of the recent NHS review. District Health Authorities are to become the identifiers and "purchasers" of health care. They are freed from the operational management of health facilities, (the "providers") such as hospitals, community services and so on. This should enable the District Health Authorities to concentrate on achieving optimum improvement in the health of the population they serve. It involves an assessment of the health needs of that population including a more positive emphasis on the views of the people within it. The infor-

mation/intelligence needs of these District Authorities was the subject of the IFM Healthcare study day.

Health needs assessment programmes will be concerned not only with local incidence of disease but also with the effectiveness of available services in the treatment of disease. This is to ensure that appropriate service specifications and contracts are developed for provider units. Purchasers will have to obtain a wide range of both textual and numeric data for their needs assessment, research, and contract development activities. It has been suggested that "intelligence" units be established in purchasing authorities to acquire, organise and disseminate this information. The term "intelligence" has recently been introduced into the NHS to cover all types of information as the term "information" has previously been used in the NHS to signify only numeric and statistical data.

In September, IFM Healthcare, (a subgroup of the Medical Health and Welfare Libraries Group of the Library Association), sponsored a study day at the Department of Health to inform librarians and other information professionals on the development of intelligence units in the NHS. The programme opened with a review by a senior member of the Department on the DHA Project (also known as Project 26) which was designed to assist DHA's with the development of the purchasing intelligence function. Other speakers presented their experiences as test sites for developing these intelligence units, or as DHA's involved in developing innovative health needs assessment programmes. The impact of the "intelligence" function on the organisation of DHA's and on training for NHS managers and information professionals was also reviewed by workshop presenters.

The workshop was well attended by 65 librarians, information officers and managers and the comments expressed supported the view that it was a very valuable experience for both learning about future information needs and for networking with future colleagues. All went away with an understanding that a new blend of traditional information retrieval skills, communication skills, and statistical/numeric skills will be required for those working in this area; and that certain subjects will assume a much greater importance for them e.g. clinical outcomes and effectiveness, contract and service specification development, needs assessment research, etc.

IFM Healthcare was very pleased to have provided this, the third study day in its educational programme since its inception in 1990. IFM Healthcare was formed to support librarians and other information workers in the provision of quality and cost-effective information services to health care managers. It does this through the provision of study days, a newsletter and publications. The first two study days, "Information for Effective Management" (within the NHS) and "Statistically Speaking" were also well attended. A series of bibliographies on topics such as

business planning, medical audit, resource management, the NHS Review and contracts, proved so popular that our supplies have now been exhausted. The quarterly newsletter provides articles on key national health care management resource centres, selected reference lists on current issues in the NHS, and a bulletin board for news items.

IFM Healthcare has 126 members in the United Kingdom representing librarians, information officers and managers in the NHS, universities and independent health care institutions such as the King's Fund Centre and the Nuffield Institute for Health Service Studies. New subscribers are always welcome, particularly European colleagues working in health care settings. The cost of subscribing is only £10.00 and usually includes discounted rates at our study days!

Libraries & Copyrighting

Libraries and Copyright in the European Communities: Report of the Chairman of the Working Group on Copyright.

Bibliothèques et droits d'auteur dans la C.E.E. : rapport du Président du Groupe de Travail sur les droits d'auteur.

Une réunion est prévue pendant la première semaine de mars 1992 à La Haye. Les spécialistes des droits d'auteur

de la C.E.E. et des Etats Membres du Conseil de l'Europe y participeront. Tout bibliothécaire spécialisé dans ce domaine voudra bien le faire savoir au signataire de l'article.

In 1988 the EC Commission published the "Green Paper on copyright and the challenge of technology. Copyright issues requiring immediate action" - COM(88) 172 final. In this document the Commission stated its position regarding the proposed European copyright legislation for the first time. The Green Paper outlines the regulations pertaining to audio-visual home copying, distribution rights, and the legal protection of computer programs and databases.

In January 1989 the Commission issued a "Proposal for a Council directive concerning the legal protection of computer programs" (Official Journal C91, 12th April 1989, pp.4-16). The proposal included a lending right for computer programs, but it permitted public libraries to make standard programs available to in-house users (article 5).

As a supplement to the Green Paper the Commission issued "Books and reading: a cultural challenge for Europe" - COM(89) 258 final - which contains a statement indicating the Commission's intention to issue a proposal for action with regard to reprography.

In the course of the LIBER Annual Conference at Edinburgh the Executive Committee as well as the General Assembly took up the topic and installed a working group on copyright with me as its chairman. The working group soon had to deal with renewed activity from the EC Commission; the most important points are:

1. "Initiatives to the Green Paper" - COM(90) 584 final, Jan 1991. The document contains proposals which the Commission plans to issue. Of special importance are regulations concerned with the copying of audio-visual materials for private use, regulations concerning the legal status of databases and regulations with regard to reprography;
2. "Proposals for a Council directive on rental, lending and neighbouring rights" - COM(90) 586 final - SYN 319, Jan. 1991. In article 1 an exclusive and inexhaustible lending right for all legally protected works is proposed. This lending right comprises the right to make protected works available for in-house use. According to article 4 the member states may grant exemptions from this lending right in one or several categories on condition that the author receives adequate monetary compensation if protected works are lent by libraries (public lending right);
3. In May, 1991 the EC Council passed the first directive concerning copyright, the "Directive for the legal protection of computer programs" (Off. Journal L 122, pp.42 ff). This version no longer contains the special provision for libraries to make standard computer

programs available for in-house use, which was proposed earlier by the Commission. According to the EC Council the public lending clause for computer programs lies outside the scope of the directive (ibid. p.43).

The LIBER working group consisting of a British and a Danish member as well as the chairman discussed the legal framework in which libraries within the various members states operate. Due to the fact that there are important legal differences among EC member states the participants of the working group came to rather divergent conclusions regarding future activities. As a consequence the chairman proposed to the LIBER Executive Committee the convening of a conference on copyright in Spring 1992, to which legal experts from all member states should be invited. The conference aims at finding a librarians' position concerning copyright matters.

The success of the proposed conference, which will probably be scheduled for the first week in March 1992 in The Hague, depends on the participation of copyright experts from all EC and Council of Europe member states. The bases for the discussion have to be reports on the copyright regulations of the respective member states.

I would therefore urge librarians in all member states of the EC and the Council of Europe, who are experts on copyright regulations to participate in that conference and to prepare a report on the copyright regulations in their respective country, written in English or French. It is hoped that most reports will be received by mid December 1991, but I would be grateful to hear from anyone with an interest in the subject as soon as possible.

Lower Saxony Libraries join PICA

Les bibliothèques de Basse-Saxe adoptent le système PICA (hollandais).

In Niedersachsen (Lower Saxony) - one of the 16 federal states of Germany - the decision has now been taken for further development of the state-wide integrated library system.

Libraries will adopt the Netherlands PICA-System. With the new Bundesland Sachsen-Anhalt, bordering Lower Saxony in the East also planning to join the network, one of the largest automated library systems (networks) in Europe is developing here. It is envisaged that more than ten million machine-readable records for holdings of a

total of more than 40 million volumes will be made available.

The time schedule foresees first the replacement of the central library computer unit for the Niedersachsen Region in Goettingen, and the change-over from the present cataloguing system in Lower Saxony to that of the PICA-System. This will be followed by the set-up of OPACs, the automation of loan services and ultimately that of acquisitions. Individual libraries (presently 30 in Lower Saxony) will be grouped in ten local systems in the process. It is planned to have the measure completed in 1994. This will no doubt lead to an increase in efficiency and productivity of the research libraries in the region.

Based on this far-reaching cooperative system the services of European medical libraries are also expected to profit from this development.

National Medical Bibliography

Bibliographie médicale nationale

Since 1947 the annual *Bibliographia Medica Cechoslovaca* (BMC), published by the Institute for Medical Information in Prague, has provided comprehensive information on Czechoslovak medical literature. It records all the monographs, transactions, and journal reports in medical sciences and related fields. In 1978 the BMC computerized database was introduced allowing both online and offline retrieval. At the present time it is available as a monthly index (subject - author), on 5,25 diskettes (updated monthly), and as an online database with files back to 1983 and comprising some 90,000 records.

Between 11,000 - 12,000 new items are added each year. Records contain full descriptive information including English titles, descriptors, and in some cases also abstracts. Indexing is carried out using the MeSH classification system. Recently the computerized Czech - English version of MeSH has been completed which should in future be employed as the authoritative source for cataloging in our medical libraries. We hope that by 1993 the entire BMC database will have been made available on CD-ROM.

No one should underestimate the importance this NLM offer represents. This program should offer an excellent training opportunity for an individual who has been identified as a future leader in medical librarianship. This is a competitive program; one individual can be selected each year. We hope EAHIL Members will take advantage of this great opportunity.

The National Library of Medicine Associate Program is a one-year postgraduate training experience to prepare librarians for future leadership roles in health sciences libraries. The Associates are introduced to a wide range of technologies and skills utilized in managing information at a national library and providing information services to a country or region. The Program uses a variety of teaching methods to enhance the individual's learning in the work environment.

The NLM is offering one position in the Associate Program to a librarian from outside the United States. The position is open to librarians of non-US citizenship who have an advanced degree, preferably a Master in Library Science or its equivalent, and are currently engaged to work in a medical or health sciences related library information center outside the United States. This opportunity is most beneficial for librarians working in management positions in larger libraries that are using automation and have national or regional responsibilities.

PROGRAM FEATURES

Phase I (September 1992-February 1993). As a group the Associates receive an in-depth orientation to the national Library of Medicine including its major programs and services, related technical training, selected hands-on experience, and relevant management issues. There are seminars on the developments and trends in the information field. Visits to noted libraries in the area and attendance at selected professional meetings are part of the program. The purposes of the first phase of the program is to provide broad knowledge about the programs and services at large-scale, diverse and highly technical medical library and to promote an awareness of future directions of disseminating medical information.

Phase II (March-August 1993). Under the guidance of staff members, each Associate will undertake 1-2 individualized projects related to the study, research or evaluation of library programs and services. The results of the projects are documented in written reports and oral presentations. The purpose of the projects phase are to create a self-directed course of study and investigation, to

meet the challenge of interpreting results for decision making in a library environment, and to develop professional skills and work experiences which can be transferred to the Associate's own library.

REQUIREMENTS

- Applicants must have a Master's in Library Science or equivalent in addition to an undergraduate degree;
- Applicants whose native language is not English must present evidence of having passed the TOEFL examination with a score of 600 or above;
- Applicants must enclose a written recommendation by a government agency or institution from the country to which the applicant will return, or by an association supporting information service or library development in that country, indicating how this applicant will be able to apply the information services in the country;
- Applicants are responsible for making and paying for their travel arrangements to and from Washington, DC to participate in the program. NLM will assist the applicant in locating housing but will not be responsible for housing the applicant. NLM is seeking approval for a stipend of of \$26,800 to cover living and other incidental expenses for the one year program. Applicants may submit applications contingent upon NLM's success in obtaining this approval. Applicants are responsible for making their own arrangements for accompanying members of their immediate family.
