

EDITORIAL

A Core List of Reference Books for the European Medical Library ?

Many of you will perhaps know and use the "Brandon Lists", which are published and updated in the Bulletin of the Medical Libraries Association. The books and journals that they recommend are standard texts and important journals for those practising medicine and allied disciplines in the USA.

Recently there has been move to produce a British equivalent of the Brandon list for medicine. The booklet "Core Collection of Medical Books and Journals - 1992", which contains the recommendations of the Medical Information Working Party, compiled by Howard Hague and Michael Jackson, appeared early in the year. Some 224 journals are recommended and over 800 books. It has proved very useful in checking our holdings - to make sure that we have the essential material in each medical speciality, but it also caused me to wonder how our colleagues in the rest of Europe might view such a list. It is surely biased towards English language publications and towards UK publishers, but nevertheless such compilations can be useful, since they contain recommended texts and journals. Perhaps there are similar lists for those practising medicine in France, Germany, Spain, etc. each with a particular language bias. If so, it would be useful document their existence. Eventually we might have a truly European Core List of Books and Journals in Medicine.

In addition, or perhaps as a beginning of this process, we might document useful reference books for medical librarians, but this will only succeed if you, the readers, participate in this process.

Une liste d'ouvrages de références essentiels pour les bibliothèques médicales européennes ?

Nombreux sont ceux d'entre vous qui, peut-être, utilisent les "listes Brandon" publiées et mises à jour dans le Bulletin de l'Association des Bibliothèques Médicales (américain). 

Montpellier news

The Third European Conference of Medical Libraries from 23-26 September was a very successful event: more than 600 participants attended the Conference and about 50 exhibitors presented their products in the attractive congress center CORUM in Montpellier. A variety of interesting papers and posters were delivered and received positive echoes, as did the Continuing Education Courses. A detailed report will follow in the next issue of the newsletter.

The Executive Board held meetings on 23rd and 26th September: the financial report 1991/1992 and the budget 1993/1994 were accepted. The Norwegian offer to hold the 4th European Conference of Medical Libraries in Oslo in Summer 1994 was accepted.

The Council Meeting took place on September 23. Different topics were discussed: the EAHIL President, Monique Cleland, gave a report on EAHIL activities (this will be published in a later Newsletter issue). The Council approved and accepted the financial report and the budget 1993/1994, which was also presented and accepted by the Members at the General Assembly. The following four propositions were accepted by the Council members :

1. For EAHIL meetings all reports from the various officers, committees or working groups will have to be distributed at least a month before the meeting and suggestions made ahead of the meeting;
2. Since the name of the Nominating Committee has led to confusion it will be changed to the "Election Committee";
3. Standing Committees, such as Continuing Education Committee will be dissolved and working groups will be formed for special projects instead. Once their project has been accomplished, within the time limit, the working group will then be dissolved. The only committee that remains is the "Fund Raising and Membership Committee", chaired by one Member of the Executive Board. As has already happened or as a result of this decision the following committees have been dissolved: Continuing Education Committee, Events Committee, Publication Committee.
4. A second revised edition of the Directory of Medical Libraries in Europe will be published soon. The same software, that was used for the first edition will be used. EAHIL members who are interested in participating in the working group for the second revised edition of the Directory of Medical Libraries in Europe should contact Roselyne Hoet, EAHIL secretariat, Brussels.

The General Assembly on September 23. The membership was informed of the decisions taken by the Executive Board and the Council on that day. The members accepted the financial report and the budget 1993/1994, which

included an increase in the membership fee of 10%.

The Nominating Committee made the 1992 election results known and the new members of the Executive Board and newly elected Council members were welcomed.

Cooperation and Health Libraries in Bologna University *Coopération et bibliothèques biomédicales à l'Université de Bologne*

Après une période d'éparpillement, les bibliothèques biomédicales de l'Université de Bologne ont décidé de s'unir autour de deux thèmes: instauration progressive des nouvelles technologies grâce au C.I.B. (Centre interfaculté des bibliothèques), pour une gestion unifiée, et formation professionnelle des bibliothécaires; tout ceci dans le cadre formel appelé "zone de la biosphère" (bibliothèques de santé plus bibliothèques des sciences biologiques). Le réseau ALMANET permet, même chez soi, d'être relié aux catalogues de signalement (SBA et autres) et aux bases de données en ligne anglaises et américaines. Des CD-ROM permettent aux utilisateurs l'accès direct à MEDLINE et des cours leur sont prodigués de même qu'aux bibliothécaires. Un projet prévoit aussi d'inclure une base de données portant sur la littérature grise produite par instituts et départements. Tout ceci contribue à faire évoluer l'image des bibliothèques de l'Université de Bologne mais beaucoup reste à faire encore pour que s'instaure, au sein de cette "Biosphère", une réelle coordination et coopération.

The University of Bologna, one of the most ancient in Europe, has drawn inspiration from its IX Centennial celebrations to modernise its library system. The biomedical libraries, which are dependent on institutes and hospitals, have suffered from excessive compartmentalisation and labour shortages for both historical and territorial reasons. The choice of new technologies and the development of information science have partially overcome these difficulties.

Since its creation in 1989, the Interfaculty Centre for Libraries (CIB) has unified the management of the academic libraries by developing automation and promoting participation in national and international projects. Moreover the professional education of librarians has been encouraged, enabling them to operate with the new information technologies.

Particular importance has been assigned to automation - it being the only way to overcome the shortage of resources, especially human resources; promote the development of services and effect the rationalization of libraries.

Services

The links are provided by the academic network ALMANET. All academics can access ALMANET, even from home, and can consult the on-line catalogues of the Academic Library System (SBA). Moreover the databases and catalogues of more than a hundred academic libraries and bibliographic systems all over the world are also available on-line, especially those in the U.K. and the United States (for example BLAISE and Library of Congress). The filter programme ALMATEL allows these operations.

The form of cooperation and contract for the request of copies and articles is the responsibility and choice of the

librarians. The automated national catalogue of ISRDS-CNR archive will soon be available for consultation.

The SBA catalogues also include the local archive of the National Library System (SBN) which is the national on-line archive of monographs. When the Index System is activated in the near future, cooperative cataloguing will be possible at national level.

The local system of information retrieval is an OPAC (Online Patron Access Catalogue) and searches can be made by index keywords or free text from any part of the record. Since 1985 there has also been an on-line archive of short titles, with minimal bibliographic descriptions and this is included in the SBN archive.

The local archive will be interconnected both with the Index System of SBN and with other systems particularly those of other local institutions, such as USL Health Care Unit and district (Regione Emilia-Romagna).

Organisation and other facilities

In Bologna University all the biomedical libraries are included in the Biosphere Area, particularly in two sectors: Health Care (the clinical libraries) and Basic Biological Sciences (non-clinical). The latter includes different disciplines, ranging from biology to pharmacology and veterinary science. In the scheme I describe, the Sector is a unit that organises several libraries, with a coordinator librarian for bibliographic services and other activities. Every sector must be modelled on the virtual library, that is one in which the bibliographic collection seems much more extensive than in reality.

Unfortunately few of the libraries, of the many that are included in these two sectors, are already connected to ALMANET. The links to this and to CIB have to be made as soon as possible.

Search facilities on MEDLINE CD-ROM are already in place, at least in the central biomedical and clinical libraries. The users can search individually or with the assistance of the librarian, especially for the use of the thesaurus. Periodically courses are organized for both librarians and users.

Finally, the plan also involves an academic pilot project for creating an on-line database containing the grey literature produced by institutes and departments. A survey has recently been conducted on the different formats of grey literature by means of a set of questions related to the construction of the database, which would be compatible with SIGLE rules of description (COSATI).

Conclusion

This new organisation has created remarkable changes in

the image of the biomedical libraries in Bologna University, but many things remain to be done in order to improve the professional level of the few qualified librarians and of other professionals with different backgrounds.

One of the most important aims is to solve the problem of fragmentation in as short a time as possible. There are too many libraries attached to different university hospitals and academic institutes. An effective answer may be found in the efforts of cooperation and coordination both inside sectors and between the sectors and the Biosphere Area.

Les bibliothécaires hospitaliers s'associent : quelques exemples français *Hospital librarians cooperate: some French examples*

Documentation within hospitals is fully developing. More and more technical and specialised documentation in hospitals requires information specialists. At present, there is no legal status, within the public administration of hospitals, for recognising this very special job. This article aims to reflect the present worries of hospital librarians and documentalists: it is both a reflexion on the status of hospital librarians and also a description of personal and collective initiatives on this subject.

La documentation au sein de l'hôpital est en plein essor. De plus en plus technique et spécialisée, celle-ci doit faire appel à des professionnels de la documentation. La législation actuelle au sein de la fonction publique hospitalière ne reconnaît pas la spécificité de cette fonction. Cet article se veut un reflet des préoccupations actuelles des bibliothécaires et documentalistes hospitaliers : c'est à la fois une réflexion sur un statut propre et également un descriptif d'actions individuelles et collectives autour de ce thème.

Richesse et diversité de la documentation hospitalière

Depuis le début des années 1980, avec l'arrivée des nouvelles technologies, l'avancée du professionnalisme, la gestion de données en nombre croissant, la mise en place de réseaux locaux, la diversité des utilisateurs potentiels de la documentation hospitalière, une impulsion nouvelle a été donnée à la documentation au sein de l'hôpital.

Les hôpitaux publics, en France, se divisent en 3 catégories d'établissements :

- la première catégorie concerne le centre hospitalier régional (CHR) et le centre hospitalier universitaire (CHU) qui assurent des activités de soins, d'enseignement et de recherche dans des domaines très spécialisés;
- la deuxième catégorie concerne le centre hospitalier général (CHG) ayant une fonction d'hôpital de secteur, et qui peut également être spécialisé (hôpital psychiatrique, hôpital pédiatrique);
- la troisième catégorie concerne l'hôpital local qui regrou-

pe l'hôpital-hospice et l'hôpital rural. Il dessert la population de régions éloignées des grandes agglomérations. Ces hôpitaux sont gérés par un conseil d'administration présidé par le Président du Conseil Général si l'hôpital est départemental, ou le Maire de la ville si l'hôpital est municipal;

Tous ces hôpitaux réagissent différemment par rapport à la gestion de leur documentation, qu'elle soit médicale, paramédicale, administrative ou technique. On assiste depuis ces dernières années à un intérêt croissant des équipes de direction et du corps médical pour la documentation au sein de l'hôpital. Aussi fait-on appel de plus en plus à des professionnels, bibliothécaires ou documentalistes hospitaliers.

Le rôle des institutions

La Direction des hôpitaux s'est intéressée au développement des bibliothèques médicales et a incité



chaque hôpital à créer sa propre bibliothèque.

Une enquête de la Conférence des Présidents de C.M.E. (Commission Médicale d'Etablissement) en 1989 a synthétisé les réponses et a présenté des résultats très inégaux, mais qui, tous, reflétaient un réel besoin. Les directeurs généraux des Centres Hospitaliers Universitaires ont également pris, en 1991, cette question à cœur.

Ainsi, les professionnels recrutés dans les hôpitaux publics pour prendre en charge des structures telles que bibliothèques médicales, paramédicales, administratives, centres de documentation, etc. doivent-ils correspondre de plus en plus à des profils déjà existants et définis.

Au sein des hôpitaux, on trouve : des archivistes, des bibliothécaires et des documentalistes.

Le statut de la profession

A l'heure actuelle, le statut de documentaliste ou bibliothécaire hospitalier est inexistant, car la fonction publique hospitalière française ne reconnaît pas la spécificité et la fonction de documentaliste.

Cela crée des situations statutaires très différentes selon les établissements hospitaliers qui possèdent des bibliothèques ou des centres de documentation. Les personnes qui s'en occupent sont : agent de bureau, secrétaire, secrétaire médicale, infirmière, adjoint des cadres, chef de bureau, titulaire, contractuel, catégorie B ou A selon les cas, ... Tous les cas de figures sont donc représentés. La plupart du temps, l'évolution de la carrière est assez lente.

Cette situation pose également le problème de la reconnaissance du métier au sein de l'hôpital lui-même : il y a souvent confusion des titres et des compétences. Le rôle et la fonction du documentaliste restent donc à déterminer.

Aussi assiste-t-on depuis quelques années à l'émergence de mouvements associatifs divers qui ont en commun une volonté de reconnaissance de la profession.

Les bibliothécaires hospitaliers s'associent.

L'Association des Documentalistes-Bibliothécaires Hospitaliers (ADBH) créée en 1985 à Lyon :

depuis 1972, des rencontres informelles avaient lieu entre documentalistes des écoles paramédicales privées et publiques de la région lyonnaise. Echange d'informations, réflexion sur un statut spécifique, relations avec des documentalistes de Montpellier marquent ces années. Un groupe de travail élabore un projet de statut, et c'est en 1985, afin de donner plus de crédibilité à celui-ci, que l'ADBH est créée (J.O. du 15 mai 1985).

En moins de 10 mois, le petit groupe de 5 personnes réussit à rassembler 70 documentalistes représentant plus de 40 départements : les 2/3 exercent dans des centres de formation, les autres à l'hôpital. Cette association poursuit ses activités à l'heure actuelle.

Le réseau des documentalistes des centres hospitaliers spécialisés (CHS)

Ce groupe a démarré en 1984 avec 9 documentalistes. Actuellement, 32 documentalistes (publics ou privés) se sont regroupés, issus des bibliothèques médicales et des centres de documentation paramédicaux et administratifs. Une rencontre annuelle de deux journées a lieu. Ce qui a déjà été réalisé :

- un catalogue collectif des périodiques reçus dans chaque centre de documentation avec l'état des collections
- un catalogue des ouvrages anciens de psychiatrie - un catalogue collectif des thèses et mémoires - une liste de mots-clés - un catalogue collectif de documents audio-visuels

Le prêt entre bibliothèques et l'échange de bulletins documentaires ainsi que le choix commun d'un logiciel documentaire (TEXTO) sont à signaler. Ce groupe désire rester informel.

Un second mouvement associatif est celui notamment appuyé par Mr Alain Halbout, Président du Centre National de l'Équipement Hospitalier (CNEH), et par la Conférence des Directeurs Généraux de CHU : deux réunions se sont déjà tenues à Paris afin de réfléchir sur les problèmes de la profession. Cette réflexion a porté sur le fait que les établissements hospitaliers ont un besoin sans cesse croissant d'informations rapides nécessaires à la prise de décision. Or l'apport de ces informations ressort de compétences spécifiques, d'un métier. Une approche sur un statut spécifique a été entreprise ainsi que la mise en chantier d'un annuaire professionnel. Nul doute que cette initiative portera ses fruits. Elle a le mérite de mettre en avant certains problèmes, de réunir les professionnels et d'être ainsi l'occasion d'échanges. La prochaine réunion est prévue au mois d'octobre 1992.


Il existe également le groupe sectoriel "Médecine, pharmacie, biologie" au sein de l'Association des Documentalistes Bibliothécaires Spécialisés (ADBS). Ce groupe correspond cependant mieux aux attentes des documentalistes de l'industrie pharmaceutique qu'à celles des documentalistes des hôpitaux.

Conclusion

Dans l'état actuel des choses, le statut du documentaliste ou bibliothécaire à l'hôpital demande à être clairement mis à plat. Souhaitons que grâce aux différentes initiatives et

European Communities declare European Health and Safety at Work Year, from March 1, 1992 to March 1, 1993

La C.E.E. déclare "Année européenne pour la sécurité, l'hygiène et la santé sur le lieu du travail", du 1er mars 1992 au 1er mars 1993

By declaring 1 March 1992 to 1 March 1993 as European Year of Safety, Hygiene and Health Protection at Work (Année européenne pour la sécurité, l'hygiène et la santé sur le lieu de travail), the Commission of the European Communities Health and Safety Directorate wishes to emphasize actions concerning a crucial problem: the human and economic aspects of accidents at work and of occupational diseases. Of the 150 million workers in the community nearly 10 million are affected each year by accidents or diseases at work. For these an estimated 20.000 million Ecu of indemnities are paid annually.

The Consultative Committee for Safety, Hygiene and Health Protection at Work is cooperating with the appointed national liaison committee. The EAHL secretariat will provide you with the list of representatives of these national liaison committees upon request.

During the European Year the European Foundation for the Improvement of Living and Working Conditions, together with the CEC, is distributing free of charge a newsletter in the Community working languages HYGEIA (ISSN 1019-052X), Loughlinstown House, Shankill, Co. European Communities - Research proposals

Les Communautés Européennes - projets de recherche

Ces projets de recherche font l'objet d'une deuxième série d'allocations et doivent être reçus à la DG XIII jusqu'au 15 février 1993. Un document publié par la CEE, DGXIII-B peut aider à l'élaboration de ces projets. Il s'agit du "Programme des bibliothèques: appel aux projets pour 1991 : revue générale", mai 1992.

The Second Call for Proposals for EC funding for projects relating to libraries will be published in the Official Journal of the European Communities in mid October 1992. Proposals for the second round of funding have to be received at the Directorate General XIII (Telecommunications, Information Industries and Innovation) by 15th February 1993.

There are two recent EC documents which would be of use to anyone intending to make a research proposal and which may be of general interest: Commission of the European Communities. DGXIII-B, Libraries Programme: Call for Proposals 1991: an overview, May 1992.

This document was prepared to disseminate the experiences and results of the first Call for Proposals launched in the libraries area last year. Its aim is to help with the preparation of proposals for future calls. The "Action Lines" are outlined and the response in terms of both Action Lines and participating countries is represented graphically. There is a figure showing that libraries were 48% of the respondents and that academic libraries made up almost half of these, etc. There is also a short overview of the fourteen proposals retained, but no more than the

titles. A short description of the aims of each of the projects is in the Library Association Record⁽¹⁾.


The Judy Segal Trust was established in 1990 in memory of Judy Segal, who was a senior paper conservator at the Bodleian Library in Oxford until her death in November 1989.

The Trustees now invite applications from individuals and institutions in less developed countries for assistance from the Trust for projects which would further the preservation and conservation of archive and library materials. The types of project which will be considered favourably include assistance for conservators from less developed countries to undertake short-term internships or to attend workshops, seminars, short courses, etc. and the provision of experienced conservators to undertake short-term consultancies or to act as instructors in less developed countries.

Grants will normally be in the range of £2,500-£5,000. Preference may be given to projects in which the beneficiaries offer to meet part of the costs or in which the Trust would be co-sponsor with other funding agencies. In some cases the Trustees may themselves be able to identify co-sponsors.

Applications for 1993 and future years will be considered in the Spring and Autumn. The deadlines for 1993 will be 1 April and 1 October. United Kingdom - The information needs and information seeking behaviour of nurses: summary of a report

Royaume Uni - Résumé d'un rapport sur les besoins d'informations des infirmières ainsi que sur leur attitude vis-à-vis de cette recherche d'informations

The information seeking behaviour of nurses project has sought to identify the kinds of information sought by practising nurses, student nurses undergoing basic training and nurses following post basic courses. The use of libraries by nurses was investigated. The Project team consisted of Maurice Wakeham, Faculty Librarian for Health & Social Work at Anglia Polytechnic, and Judith Houghton and Simon Beard of the Faculty of Health and Social Work.

The survey was carried out in four Health Districts in South and Central Essex. The provision of nurse education in these Districts through the two Associated Departments of Nursing and Midwifery Education of Anglia Polytechnic is described and set in the national context. The literature of nurses' information needs, reading habits and library skills, and library provision for nurses is reviewed.

The study was carried out by means of a questionnaire distributed to a convenient sample of nurses and student nurses. 50.15% (501) of the forms distributed were returned.

The analysis of the survey shows that the particular group of nurses who responded most often need information in relation to patient or client care and for their own personal interest. They are least interested in information that

relates to new courses or jobs or in preparing for interviews for them. An individual's own journals and their nursing colleagues are the main sources of information. Library and information services were found to be relatively little used except when research or course work were being undertaken, though 42% of our sample claim to visit a library approximately weekly. A School or College of Nursing library is most likely to be visited. Asking the librarian and browsing the shelves were the most common ways of finding information in the library. Books and journal articles were the most used forms of information. The most frequent suggestions made by respondents for improving library services were to increase resources available for materials, to change opening hours and to improve promotion of services.

Libraries are seen to have a small but expanding role in nurses' information seeking behaviour, particularly in relation to pre-registration and continuing nurse education. While there is a need for increased resources, a mutually supportive partnership between students, nurses, educationalists, managers and librarians will be necessary if effective and proactive library services for nurses are to develop.

NEWS FROM OUTSIDE EUROPE

Glimpses from the 92nd Medical Library Association Meeting in Washington DC

Un regard sur le 92ème Congrès de la Medical Library Association à Washington DC

The main theme of the Conference was "Choose to make a difference". It was the largest MLA meeting ever held. The participants could choose among four parallel debates, section and luncheon meetings, poster sessions, the exhibition and even informal meetings scheduled on the spot.

Richard Lyders emphasized, in his welcoming presidential address, the importance of professional and continuing education of librarians and information specialists to build up expertise and knowledge in their various professional roles as for instance leaders, managers and developers of automated library systems, educators of library

users and scholars in library and information science.

The opening keynote speech was given by Warren Bennis. In an excellent lecture he stressed that "leadership is a determinant for both success and failure". He found that a strong sense of purpose, the generation and sustaining of trust and a sense of optimism are important characteristics of a leader. "Failure is not the crime, low aim is", he concluded. The same theme was discussed in depth the next day, when the statement "Librarians should be Chief Information Officers (CIOs)" was debated. Robert Braude remarked that "library culture is process-oriented rather than outcome-oriented". The library concentrates on the process to maintain a good outcome - the information officer prefers to take the quick way to reach a solution. Both strategies have their risks.

Assessment of quality of reference work was the topic of a very entertaining and interesting session. In order to

analyse reference work one has to look at ethics, accuracy, completeness, receptivity, interview technique, user instruction, participation and user satisfaction.

Libraries serving problem-based medical schools had a special session as well as an informal meeting where a special problem-based learning interest group was formed. Interesting preliminary results of a user survey at three Canadian medical schools were reported by Dorothy Fitzgerald and Joanne Marshall. Their results verify the felt importance of the library in the educational programmes of the schools. The speakers shared their experiences of user education programmes and strategies for collaboration with faculty and students with an active audience.

Ten years of progress of NLM's extensive grant programme IAIMS (Integrated Academic Information Management Systems) were described at a special session on leading edge technologies. Donald Lindberg confirmed that the programme is a success, its goals having been achieved, by and large. The institutions that have reached the implementation phase of development so far, show that it is possible to manage institution wide integrated information networking programmes. The new governmental High Performance Computing and Communication (HPCC) project in the USA will in the future enable IAIMS institutions to cooperate and network with each other and with other institutions.

Nancy Roderer gave examples of IAIMS implementations at various institutions, for instance, the Columbia Presbyterian Medical Center. The library and scholarly information is physically accessible through the same menu as the administrative systems, patient-related systems and information about patients, and will thus directly support clinical care. Naomi Broering described a project where libraries could access the Georgetown integrated library system using Internet.

NLM was of course at the exhibition and demonstrated new versions of Grateful Med and Loansome Doc, new developments in UMLS and a CD-ROM of the GenInfo database. The System for Automated Interlibrary Loan (SAIL) project was described in a paper.

As networking and communication skills were central topics at the conference, one could conclude that the 1990s are going to be the decade of communication.




